A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "INTERGOVERNMENTAL SUPPORT AGREEMENT BETWEEN NAVAL AIR STATION KEY WEST AND CITY OF KEY WEST FOR SUPPORT SERVICES" (IGSA), AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE THE AGREEMENT ON BEHALF OF THE CITY, UPON THE ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the US Department of the Navy, as represented by the Naval Air Station Key West (NAS) and the City of Key West find it is beneficial to both entities to provide certain support services to each other; and

WHEREAS, NAS Key West is authorized pursuant to 10 U.S.C. Section 2679 and the City of Key West is authorized pursuant to Florida Government Code Section 163.01 to enter into an IGSA to provide service and goods contracts as mutually agreed upon, and is the result of the Parties' mutual efforts to reduce costs, create efficiencies; and

WHEREAS, the IGSA is anticipated to generate revenue for the City, by providing certain solid waste and recycling services to NAS Key West at reasonable cost, inclusive of an administrative

fee provided to the City, and will be subject to annual updated task orders or contracts for service; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "INTERGOVERNMENTAL SUPPORT AGREEMENT BETWEEN NAVAL AIR STATION KEY WEST AND CITY OF KEY WEST FOR SUPPORT SERVICES" is hereby approved.

Section 2: That the City Manager, or his designee, is hereby authorized to execute the above-described Agreement on behalf of the City, upon the advice and consent of the City Attorney.

Section 3: That income, as an administrative fee on each invoice submitted through the billing and payment process shall be allocated in the appropriate account.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
