	On 10-31-2015, I Matthew Hansell of the Key West Police Department, was working this day as part of an off duty assignment for Fantasy Fest. Myself and K-9 Ofc. Anglin were walking back to Green St. after assisting with a verbal argument in which a female was arrested near Irish Kevin's Bar. As I walked toward Greene St. I could hear screaming and yelling coming from The Lazy Gecko located at 203 Duval St. We were approached by an employee who told us that there was a fight occurring inside. Myself and K-9 Ofc. Anglin approached the front doors and I saw a very large crowd of black males engaged in a violent brawl with one white male. I told dispatch of what was occurring and requested more units. I shouted at the crowd to " stop, " as I activated my taser. The large group of males ignored mine and K-9 Ofc. Anglin's verbal attempts to get them to stop. It was clear that my taser would have little effect on so many people as I could not find a primary aggressor. There was also further chance of injury to myself or K-9 Ofc. Anglin, if we attempted to go hands on and engage the crowd. I determined based on the hostile nature of the crowd fighting, the safety of Officers as well as patrons inside the bar, that the best course of action to stop the fight would be to introduce OC Spray. I took out my department issued MK-3 OC Spray in order to put and end to the violent brawl. I shouted at the males involved in the brawling to stop once more. The males continued to ignore my commands and kept fighting. The crowd continued to be aggressive and hostile in nature. I delivered several burst of OC Spray onto several males who were involved in the brawling. The OC Spray was effective as the crowd quickly dispersed from inside the Lazy Gecko and onto Duval St., joining the large Fantasy Fest crowd. As the crowd cleared I made contact with the white male involved in the fight, had his shirt torn off and was visibly upset. He had a very strong odor of an alcoholic beverage coming from his breath along with slurred speech. He was complaining about being sprayed with OC Spray as I had him collect his shoes. walked toward Sloppy Joe's and was eventually stopped by Ofc. Andruzzi along Greene St. As other officers arrived on scene to assist with crowd control, I spoke with several employees inside of

the Lazy Gecko. The employees at that time were not sure how the fight started. Several males were detained outside the Lazy Gecko, however it was impossible to determine who was involved in the fight other than Tyler.

I went back to Greene St. and made contact with [redacted] who was still very much intoxicated and visibly upset. [redacted] would not speak with us and kept making smart comments. It was as if [redacted] thought everything was joke.

As we stood with [redacted] it was clear he could not be left on his own due to his extreme intoxication. I placed hand cuffs on [redacted] in order to place him into protective custody under the March Man Act.

[redacted] who was still feeling the effects of the OC Spray and intoxication resisted my attempts at the being placed into hand cuffs. [redacted] was assisted to the ground by Ofc. Andruzzi and myself. I was able to place hand cuffs on [redacted] once he was on the ground [redacted] was then escorted to the Command Center on Anne St.

While processing [redacted]'s paper work I was met by the manager of the Lazy Gecko Paul Brady. Paul thanked me for putting an end to the fight. Paul also told me that [redacted] was more of a victim of the fight than an instigator from what he saw.

Paul watched [redacted] get punched in the face by an unknown black male who he did not know. After speaking with Paul I completed [redacted]'s paper work. [redacted] was still uncooperative at the scene and refused to speak with me about the fight.

I requested Fire Rescue to check [redacted] due to being OC Sprayed. Fire Rescue arrived on scene, however [redacted] refused treatment.

[redacted] was eventually taken by MCSO transport van to the Monroe County Jail.

I later met with Sgt. Haley and briefed him of the incident.

At the time of the brawling I was unable to activate my BODY CAM due to how quickly the fight escalated. I did activate my taser for a moment before transitioning to my OC Spray.

My BODY CAM was activated once [redacted] was taken into custody.

I took no further action

	1	On 10-31-15, at about 0308 hours, I was working the Fantasy Fest detail when there was some sort of disturbance at the Lazy Gecko. From what I understood, pepper spray was used to disperse a crowd that was fighting. There was a very large festival crowd in the 200 block of Duval and there were many intoxicated people who were starting to get rowdy. I was in the 400 block of Greene Street and saw a man that I recognized as a local resident rubbing his eyes and running around like he was in pain and possibly intoxicated. His friends were trying to get him home. At one point, he punched a portable toilet. Local resident Marvin Smith, said the man was in the Lazy Gecko when a fight broke out and they man got pepper sprayed. The man just wanted to go home. One of his friends got him some water and poured it in his eyes. I gave him advice to blink and use water and air to wash the pepper out. The man was difficult to talk to and just wanted to get to a shower. I was told over the radio that the victim in the incident could not be found, and I knew that I could find this man again if necessary and I had no charges on him, so rather than keep him from being able to reduce his pain, I let his friends try to get him home. There was also a girl that appeared to have some spray in her eyes, but I lost track of her in the mayhem. Part of this incident was captured on my body camera.

N A R R A T I V E	Topic	SUPPLEMENTAL
	On 31OCT15 at 0308, Ofc. M. HANSELL and I, (Ofc. T. ANGLIN) were clearing from an incident at Irish Kevin's Bar and began walking towards Greene Street, when we were flagged down by an employee at the Lazy Gecko Bar, located at 203 Duval Street. The employee indicated that there was a fight and as we approached the front of the bar, I could hear screaming and yelling coming from the entrance.	
	After making my way through the crowd standing on the sidewalk in front of the bar, I could see several black males punching a white male, who was on the ground, (On his back). I then observed the crowd of bar patrons move closer to the fight and one of the patrons attempt to "Stomp" on the white male in the head. I quickly grabbed the unknown black male patron by his waist and tossed him out the front door and away from the fight before he made contact with the white male's head. I un-holstered my Taser and began announcing my presence and giving loud commands for the crowd to back away and for the brawl to cease.	
	I quickly accessed the crowd and realized that my Taser with cartridge on would be ineffective due to the hostility of the crowd towards us. I took off the Taser cartridge and prepared to employ my Taser in drive stun mode if needed.	
	Ofc. M. HANSELL also accessed the situation and utilized his OC spray to break up the brawl. The OC spray effectiveness was almost immediate. The brawl ceased and the bar itself cleared out immediately. I surveyed the inside of the bar and looked for combatants. The bar was clear and as I walked out, the staff expressed their gratitude for ending the volatile situation.	
	I linked up with Ofc. M. HANSELL in front of the bar and we attempted to coral the participants of the brawl. The core participants of the brawl had blended into the Fantasy Fest crowd and disappeared. The persons I did speak with were local patrons that were exposed to OC spray. All persons I spoke with refused medical attention and denied any offered assistance from me.	
	Ofc. M. HANSELL and Ofc. M. ANDRUZZI were later able to locate the white male, who was later identified by bar employees as the victim of the brawl. I gathered information for my report and departed the scene.

	Officer Hansel told _____ he was going to be placed into protective custody under the Marchman Act. Officer Hansel attempted to place _____ hands behind his back so he could be handcuffed. _____ tensed his arms and refused to place his hands behind his back. _____ was given verbal commands several times by Officer Hansel but still refused to comply.	
	Officer Hansel and I brought _____ to the ground and were successful at handcuffing _____ . Officer Hansel then escorted _____ to the Key West Police Command Center for processing.
