I continued to travel North on Duval in hopes of making contact with Tyndall and his girlfriend. I came to a stop at the area in front of Margaritaville due to a standstill in traffic.

I observed multiple people running towards my patrol unit and pointing in the direction of the intersection of Fleming and Duval. I immediately activated my lights and sirens, maneuvered the car around the stopped traffic and stopped in front of a crowd of people.

Before I got out of my vehicle I observed a white male, shirtless, wearing cargo shorts, who I later identified as Jordan Tyndall, actively fighting with another man. I exited my patrol vehicle and multiple individuals were yelling, that's him, that's the guy that hit the girl. All of the surrounding individuals were pointing to Tyndall. Tyndall matched the description of the white male who was seen by witnesses hitting his girlfriend.

I approached Tyndall at an angle as I made my way through the crowd. I attempted to make contact from behind Tyndall. As I got close, I observed him shove another man as he walked away from me and towards my vehicle. Right before I made contact with Tyndall, within a foot or so, I yelled out "Key West Police". Tyndall continued to walk away.

At this point Tyndall was a few feet away from my patrol unit, so I grabbed his forearm/wrist area and attempted to detain Tyndall, I moved him towards my patrol unit in an attempt to use my car in detaining Tyndall. Tyndall immediately turned around towards me and I again stated Key West Police. Tyndall continued to pull away from me and Tyndall and I fell to the ground in an awkward manor, as I tried to detain him.

Tyndall continued to squirm on the ground and attempt to push up off the ground as I again yelled Key West Police, stop resisting.

At this point one of the witnesses on scene (Fermin Berrios) helped me keep Tyndall down on the ground. Berrios stated he is an off duty Police Officer out of Boca Raton, Florida. Berrios stated he observed Tyndall hit his girlfriend. Berrios stated he contacted Key West Police and tried to keep Tyndall from leaving the scene.

Ofc. Bouvier received a written statement from Berrios and two other witnesses. Ofc. Bouvier received all three written statements and will provide a supplemental report.

Upon arrival at the Monroe County Jail, I Mirandized Tyndall and he waived Miranda Rights. I asked Tyndall what happened. Tyndall stated he went to Walgreens, on Duval, with his girlfriend and her friend to buy some stuff. Tyndall stated he stayed inside to pay while his girlfriend and friend walked outside of the store. Tyndall stated he could not find his girlfriend and friend. Tyndall stated he walked down to the South end of Duval and back. Tyndall stated he asked people along the way if they have seen his girlfriend. Tyndall stated he asked one guy, and the guy said "I saw that bitch". Tyndall stated the guy followed him. Tyndall then stated the guy put his hands on his girlfriend. Tyndall stated he went at the guy, "cause no one puts a hand on his girl."

I remained at the Sally port area of the Monroe County Jail awaiting the arrival of Sgt. Smith. I advised Sgt. Smith that Tyndall was Mirandized and he waived his Miranda Rights. Sgt. Smith interviewed and took photos of Tyndall's injuries. I subsequently uploaded the pictures into COBAN. Tyndall had minor scrapes on his face, left ankle and back. Tyndall stated he believes he received the injuries during the altercation which he was in before we arrived but could not be sure.

Upon listening to Sgt. Smith's post Miranda interview reference the use of force incident, Tyndall's interview and recollection of what happened was different than what he told me.

The Medical staff at Monroe County Jail did not clear Tyndall medically do to the cuts and apparent head injury.

Tyndall did not complain of any headaches or head injury.

I remained at the Sally port area of the Monroe County Jail awaiting the arrival of Sgt. Smith. I advised Sgt. Smith that Tyndall was Mirandized and he waived his Miranda Rights. Sgt. Smith interviewed and took photos of Tyndall's injuries. I subsequently uploaded the pictures into COBAN. Tyndall had minor scrapes on his face, left ankle and back. Tyndall stated he believes he received the injuries during the altercation which he was in before we arrived but could not be sure.

Upon listening to Sgt. Smith's post Miranda interview reference the use of force incident, Tyndall's interview and recollection of what happened was different than what he told me.

The Medical staff at Monroe County Jail did not clear Tyndall medically do to the cuts and apparent head injury.

Tyndall did not complain of any headaches or head injury.

I transported Tyndall to Lower Keys Medical where he was cleared medically.

The incident, transport, transport to and from Lower Keys Medical and all interviews with Tyndall were recorded on COBAN.

I was unable to activate my BWC for the incident.

driver, Manso, then left the scene towards the area of Regal Cinema Six (Searstown Plaza).

While speaking with Amanda, Lt. Dave Black stated on the radio that he was looking through the Searstown parking lot for the suspect. Lt. Black then stated he saw the subject walking across North Roosevelt Blvd from Searstown. I left the crash scene and Officer Currel and I drove towards North Roosevelt Blvd on Toppino Drive. I saw Manso on the North side of the highway, walking back towards Searstown. I began to turn around in order to stop Manso in the parking lot of Searstown. I turned on my over head lights in order to complete the turn. Manso then turned around and ran back across the highway to the North Side of the highway. I entered traffic and traveled West on North Roosevelt Blvd. Manso left the North side of the sidewalk and ran across highway traffic towards the parking lot again.

Lt. Black entered the highway and turned his overhead lights on, cutting off Manso's path across the highway. I saw Lt. Black exit his vehicle and give Manso loud verbal commands to stay put. Manso turned around and began to run on foot, away from Lt. Black and myself, while ignoring verbal commands to stop. I exited my vehicle and began to pursue Manso on foot. I un holstered my TAZER and began to pursue Manso on foot. Lt. Black deployed his TAZER into Manso as Manso continued running. The TAZER was not effective and Manso continued to run, turning back towards Searstown's parking lot.

I caught up to Lt. Black and Manso as Manso was losing his balance on the slippery roadway surface. Manso began to fall forward, over the sidewalk curb and into landscaping rocks. Lt. Black and I secured Manso in handcuffs. Manso began complaining of back pain and other injuries. Key West Fire was immediately called to the scene reference Manso's complaints and his request.

My Body Worn Camera was activated after the foot pursuit and after Manso was secure. Manso was consistently argumentative, screaming that he could not breathe even as he spoke. Manso stated his back was hurt multiple times. Key West Fire decided Manso needed to be placed on a back board and secured due to his statements of injury. Key West Fire began to place Manso on the back board, then requested his cuffs be removed as Manso would need to be restrained on the board. I removed Manso's left handcuff at Fire's request.

Manso immediately began to resist all attempts to help him onto the backboard, grasping his hands together and refusing to let go. Manso stated he was scared that we were going to hurt him. After repeated attempts to secure Manso to the back board, Manso stated he did not want the back board.

Manso then rolled over on his side, while secured in a neck brace and complaining of injury. Manso refused to place either arm behind his back to be re handcuffed. Lt. Black and I were able to forcefully place Manso's hand behind his back and re secure him in handcuffs. Manso was then stood up and placed on the stretcher to be transported by Key West Fire.

Lt. Black's TAZER cartridge was collected from the highway after being struck by passing vehicles. Due to the wet road condition and traveling cars, there were no AFIDS collected. The TAZER cartridge was placed into Key West Property.

My COBAN in car video was active during the foot pursuit, however Manso runs out of view of the camera. The video was uploaded with crash # 15-401338.

The witness told KWPD that a white car had crashed into a curb by the Surgery Center and the driver, a Hispanic male wearing grey pants and a green shirt had fled the scene on foot. The witness, Amanda Wofsey remained on scene and met with Ofc Pettee and me on our arrival.

She told us that the driver got out of the car and seemed dazed after crashing. He sat on the curb for a moment then got up and ran to the rear of the Surgery Center. He then ran west into the parking lot of Searstown.

Lt Black was in the area searching for the driver and spotted him walking on the North side of N Roosevelt Blvd. Ofc Pettee left the scene to assist Lt Black. They attempted to stop the subject who fled across N Roosevelt Blvd several times, crossing through rush hour traffic each time. He did this after having been given loud verbal commands to stop by Lt Black. Since the male, identified as Ricardo Manso, by his Florida ID card, refused to stop Lt Black deployed his Tazer. The deployment was unsuccessful with only one probe making contact with Manso. Manso continued to try to flee on foot with Lt Black and Ofc Pettee both chasing him. He lost his footing near some landscaping and curbs in the Searstown parking lot and fell to the ground. Lt Black and Ofc Pettee were then able to handcuff Manso. See supplement reports from both officers for more information.

While Lt Black and Ofc Pettee were apprehending Manso, I conducted my traffic crash investigation. The white Kia had been travelling East on Northside Dr approaching the intersection of Toppino Dr. The road was wet from recent rain. The driver tried to turn left onto Toppino Dr but was going too fast and lost control of the car hitting a high curb and landscaping that separates the parking lot of the Surgery Center from Toppino Dr.

The drivers door was left open and the car was still in gear with the ignition in the on position. There was a brown wallet on the passenger seat and a cell phone on the passenger floor board. There was a large amount of white powder on the driver seat and the front of the car in general. I retrieved the wallet and found Manso's FI ID card. I relayed his name to Black and Pettee. I ran the car and the ID Card. I found that Manso had suspended drivers license with the most recent suspension being on 11/21/2013 for failure to pay traffic fine. There were five other prior suspensions. The F/NCIC response also listed Manso as being on Probation for a drug charge with conditions that he not drive or use illegal drugs. I passed along Manso's License status as well.

I completed a tow slip for the car and began the crash report after requesting a tow truck. While completing this paperwork, I heard Ofc Pettee and Lt Black call for additional units to assist with Manso. I had already turned off the car and put it in park. I locked the doors and took the keys with me and responded to Pettee and Black's location.

The observations of the officers and Fire personnel on scene had led them to believe that Manso was possibly under the influence of one or more illegal drugs.

When I got to Black and Pettee, Manso was actively resisting being transported to the hospital for evaluation. He was pulling away from officers and medics and was screaming in an incoherent manner. He was kicking his legs around trying to gain footing to stand up. He was placed back into handcuffs, seat belted to the stretcher and loaded into the ambulance. He was complaining of being hot and that he could not breathe. He was sweating profusely and was hot to the touch. Medics requested an officer ride to the Hospital with them. I entered the ambulance and took pictures of Manso and advised the medics that I would ride out with them.

I gave the keys to the Kia to Ofc T Anglin as well as the completed Tow Slip. I asked him to search the car and to investigate the white powder on the front seat prior to releasing the car to Arnolds Towing.

See Ofc Anglin's K-9 Usage report for further detail. He tested the white powder on the driver seat. It Field Tested Positive for Cocaine. Ofc Anglin collected the white power and later turned it over to me.

At the Hospital, Manso was treated by the attending Physician and numerous nurses. Due to his level of narcotic intoxication, it took several hours for him to be stable enough for transport to jail. During that time, it took the efforts of three nurses, five medics, two orderlies, one Physician's Assistant, Ofc Anglin, Ofc Nelson and me to hold him down for treatment and calming medications. Once his vital signs were stable,

the doctor released Manso to my custody for transport to jail.

My COBAN and BWC were intermittently active during my time with Manso due to Medical Privacy concerns. The footage that was recorded was uploaded to the server. The photographs I took of the crash scene and of Manso were uploaded as well. I also burned the pictures of Manso to a DVD with was given to Sgt Pablo Rodriguez for the response to resistance report. I placed the suspected Cocaine into KWPD Property as evidence.

Manso was driving a white Kia four door car which bore FI Tag CSCV07 and did so knowing that his Drivers License was suspended. While driving the car, Manso failed to stay within his designated lane and collided with a concrete curb causing disabling damage to the car. Manso then fled the crash scene without making any attempt to report the crash and left his car unattended. There was no insurance listed for the car and no proof of insurance was found in the car. Manso did have in his possession in the car less than one gram of collectable Cocaine. After fleeing the crash, Manso was confronted by officers and given verbal commands to stop. He continued to run from police on a busy highway at rush hour and once apprehended, continued to resist efforts at control by kicking, tensing his body and pulling his arms away from arresting officers. For these actions, Manso is charged with Possession of Cocaine, DWLS with Knowledge, Leaving the scene of a Traffic Crash with Property Damage and Resisting Arrest without violence. He was additionally cited for failure to stay in his designated lane and no proof of insurance.

	On Thursday 20, August, 2015, I responded to 931 Toppino Dr on a report of a single vehicle crash where the driver had fled the scene on foot.	
	Ofc M Pettee and Lt D Black also responded to the area.	
	The witness told KWPD that a white car had crashed into a curb by the Surgery Center and the driver, a Hispanic male wearing grey pants and a green shirt had fled the scene on foot. The witness, Amanda Wofsey remained on scene and met with Ofc Pettee and me on our arrival.	
She told us that the driver got out of the car and seemed dazed after crashing. He sat on the curb for a moment then got up and ran to the rear of the Surgery Center. He then ran west into the parking lot of Searstown.		
Lt Black was in the area searching for the driver and spotted him walking on the North side of N Roosevelt Blvd. Ofc Pettee left the scene to assist Lt Black. They attempted to stop the subject who fled across N Roosevelt Blvd several times, crossing through rush hour traffic each time. He did this after having been given loud verbal commands to stop by Lt Black. Since the male, identified as Ricardo Manso, by his Florida ID card, refused to stop Lt Black deployed his Tazer. The deployment was unsuccessful with only one probe making contact with Manso. Manso continued to try to flee on foot with Lt Black and Ofc Pettee both chasing him. He lost his footing near some landscaping and curbs in the Searstown parking lot and fell to the ground. Lt Black and Ofc Pettee were then able to

handcuff Manso. See supplement reports from both officers for more information.

While Lt Black and Ofc Pettee were apprehending Manso, I conducted my traffic crash investigation. The white Kia had been travelling East on Northside Dr approaching the intersection of Toppino Dr. The road was wet from recent rain. The driver tried to turn left onto Toppino Dr but was going too fast and lost control of the car hitting a high curb and landscaping that separates the parking lot of the Surgery Center from Toppino Dr.

The drivers door was left open and the car was still in gear with the ignition in the on position. There was a brown wallet on the passenger seat and a cell phone on the passenger floor board. There was a large amount of white powder on the driver seat and the front of the car in general. I retrieved the wallet and found Manso's FI ID card. I relayed his name to Black and Pettee. I ran the car and the ID Card. I found that Manso had suspended drivers license with the most recent suspension being on 11/21/2013 for failure to pay traffic fine. There were five other prior suspensions. The F/NCIC response also listed Manso as being on Probation for a drug charge with conditions that he not drive or use illegal drugs. I passed along Manso's License status as well.

I completed a tow slip for the car and began the crash report after requesting a tow truck. While completing this paperwork, I heard Ofc Pettee and Lt Black call for additional units to assist with Manso. I had already turned off the car and put it in park. I locked the doors and took the keys with me and responded to Pettee and Black's location.

The observations of the officers and Fire personnel on scene had led them to believe that Manso was possibly under the influence of one or more illegal drugs.

When I got to Black and Pettee, Manso was actively resisting being transported to the hospital for evaluation. He was pulling away from officers and medics and was screaming in an incoherent manner. He was kicking his legs around trying to gain footing to stand up. He was placed back into handcuffs, seat belted to the stretcher and loaded into the ambulance. He was complaining of being hot and that he could not breathe. He was sweating profusely and was hot to the touch. Medics requested an officer ride to the Hospital with them. I entered the ambulance and took pictures of Manso and advised the medics that I would ride out with them.

I gave the keys to the Kia to Ofc T Anglin as well as the completed Tow Slip. I asked him to search the car and to investigate the white powder on the front seat prior to releasing the car to Arnolds Towing.

See Ofc Anglin's K-9 Usage report for further detail. He tested the white powder on the driver seat. It Field Tested Positive for Cocaine. Ofc Anglin collected the white power and later turned it over to me.

At the Hospital, Manso was treated by the attending Physician and numerous nurses. Due to his level of narcotic intoxication, it took several hours for him to be stable enough for transport to jail. During that time, it took the efforts of three nurses, five medics, two orderlies, one Physician's Assistant, Ofc Anglin, Ofc Nelson and me to hold him down for treatment and calming medications. Once his vital signs were stable, the doctor released Manso to my custody for transport to jail.

My COBAN and BWC were intermittently active during my time with Manso due to Medical Privacy concerns. The footage that was recorded was uploaded to the server. The photographs I took of the

crash scene and of Manso were uploaded as well. I also burned the pictures of Manso to a DVD with was given to Sgt Pablo Rodriguez for the response to resistance report. I placed the suspected Cocaine into KWPDP Property as evidence. Manso was driving a white Kia four door car which bore FI Tag CSCV07 and did so knowing that his Drivers License was suspended. While driving the car, Manso failed to stay within his designated lane and collided with a concrete curb causing disabling damage to the car. Manso then fled the crash scene without making any attempt to report the crash and left his car unattended. There was no insurance listed for the car and no proof of insurance was found in the car. Manso did have in his possession in the car less than one gram of collectable Cocaine. After fleeing the crash, Manso was confronted by officers and given verbal commands to stop. He continued to run from police on a busy highway at rush hour and once apprehended, continued to resist efforts at control by kicking, tensing his body and pulling his arms away from arresting officers. For these actions, Manso is charged with Possession of Cocaine, DWLS with Knowledge, Leaving the scene of a Traffic Crash with Property Damage and Resisting Arrest without violence. 	1 On 08-20-15, I responded to a crash on Toppino Drive. The driver had reportedly fled the scene and ran behind the Regal Cinema near the crash scene. Once on scene, I obtained a suspect description and searched the Searstown Plaza. The suspect was described as a latin male, heavysset wearing a green shirt and jeans. I was flagged down by Deonte Stemage inside the parking lot of Searstown, who pointed the suspect out to me. I observed a latin male running outbound, across North Roosevelt Blvd. This male, later identified as Ricardo Manso, was running through heavy traffic (it was still rush hour at this time). Manso crossed across all five lanes of traffic several times. Manso showed no regard for traffic. I called out the suspect's location and Officer Pettee responded. As Officer Pettee responded inbound near Toppino Drive, I approached Manso outbound near the entrance/exit to Publix. Manso was now on the Publix side of North Roosevelt Blvd, but once more ran across all five lanes of traffic towards the seaside of the roadway. Once Manso noticed Officer Pettee he darted back towards Publix, towards my Patrol Vehicle. I exited my Patrol Vehicle and gave chase. I ordered Manso to stop, however he continued to flee. Not knowing if outbound traffic was coming, I attempted to tase Manso on the inbound side of the roadway. The traffic inbound was stopped at the time and blocked by Officer Pettee's Patrol Vehicle. This would have been the safest place to take him into custody. I deployed my taser, but the angle for the deployment was less than ideal and only one taser prong made contact. Manso then ran back towards the Publix side of the roadway (across all five lanes of the roadway). Manso lost his footing as he ran across the sidewalk and he slid, chest first into some landscaping between the sidewalk and the parking lot. Officer Pettee and I were able to secured Manso in handcuffs. Officer Pettee called Rescue, who responded within a few minutes. Before and during being treated by Rescue, Manso's speech pattern and the things he was saying led me to feel that he was under the influence of narcotics. At one point Manso said that he had done to many drugs. Rescue wanted to place Manso in a C Collar and place him on a backboard as he requested to go to the hospital. The EMT/Paramedic was able to place a C Collar on him, but as we were trying to get Manso on a backboard, he became agitated for some reason. Officer Pettee had taken the left handcuff off to get him on the backboard. Manso began to resist our attempts and after some struggling I decided to place Manso back in handcuffs as it was not possible to get him safely on the backboard. Manso was transported to the hospital via Rescue in an ambulance. Officer Pettee was exposed to Manso's blood on Pettee's bare skin. I sustained a strain of some sort to my left calf. Additionally, my left ring finger was caught in the handcuffs and injured. The injury to my finger was directly related to Manso's resistance. The taser deployment was caught on Officer Pettee's in-car camera. Officer Pettee's body worn camera also captured Manso's behavior just as we were handcuffing him. Both videos have been uploaded into Coban.

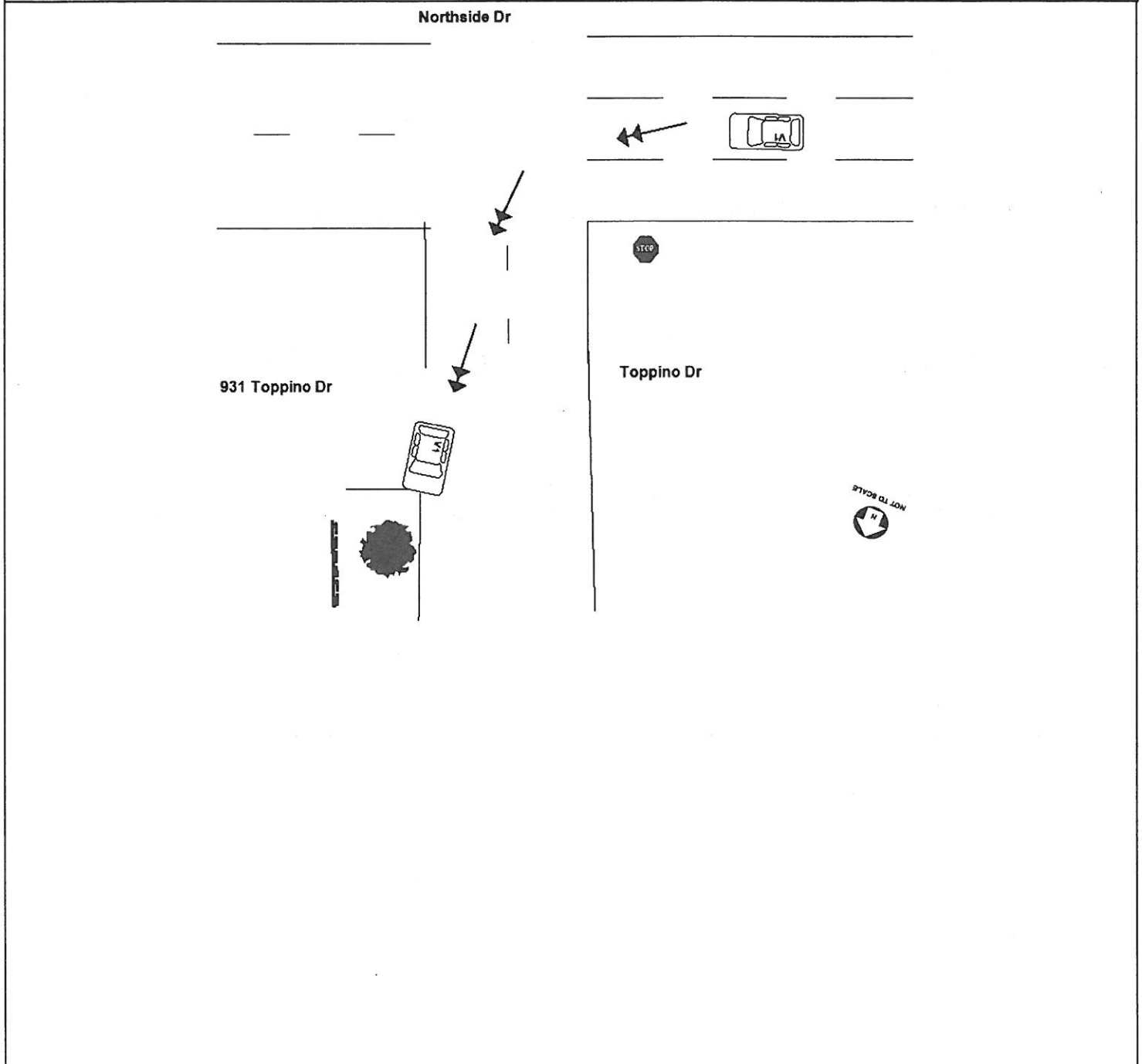

NARRATIVE

W1 told me V1 was eastbound on Northside Dr and tried to turn left onto Toppino Dr but lost control and hit the curb. The driver, a Hispanic Male in a green shirt and grey pant fled the scene on foot into Searstown.

The driver side door was open. The car was in gear and the ignition was on. The drivers airbag had deployed in the crash. There was a wallet on the passenger seat and a cell phone on the passenger floor board. I retrieved the wallet from the seat and inside I located a FL ID card belonging to Ricardo Manso. The registration for the car returned to Martha Betancourt. The ID card return showed Martha Betancourt as the emergency contact for Manso. There was a large amount of white powder on the driver seat as well as in the front of the car generally.

While I conducted the initial crash investigation, Lt Black and Ofc Pettee located and arrested Manso in Searstown. See their supplement reports for further information. 0115401338

Manso did not have a valid drivers license. It was most recently suspended on 11/21/2013 for failure to pay traffic fine. Manso was transported to the Hospital after it was determined that he was under the influence of illegal drugs. I rode with the ambulance on their request. I stood by in the hospital while Manso was treated for Cocaine and other drug ingestion.

Ofc Anglin collected the powder from the seat and cabin of the car. The powder FTP Cocaine. See his K-9 usage report for further information. 0115003841.

Manso was arrested for Possession of Cocaine, DWLS w/Knowledge, Leaving the scene of crash with property damage, as well as cited for fail to stay in designated lane and no insurance.

Manso had injuries consistent with airbag deployment on his face and arms. Due to his resistance at the time of arrest, he had other abrasions as well. He was photographed along with the crash scene. The photos were uploaded to the COBAN server.

The car was towed by Arnolds Towing.

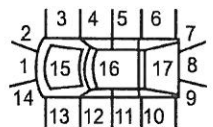
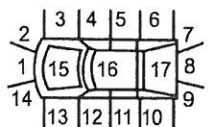
