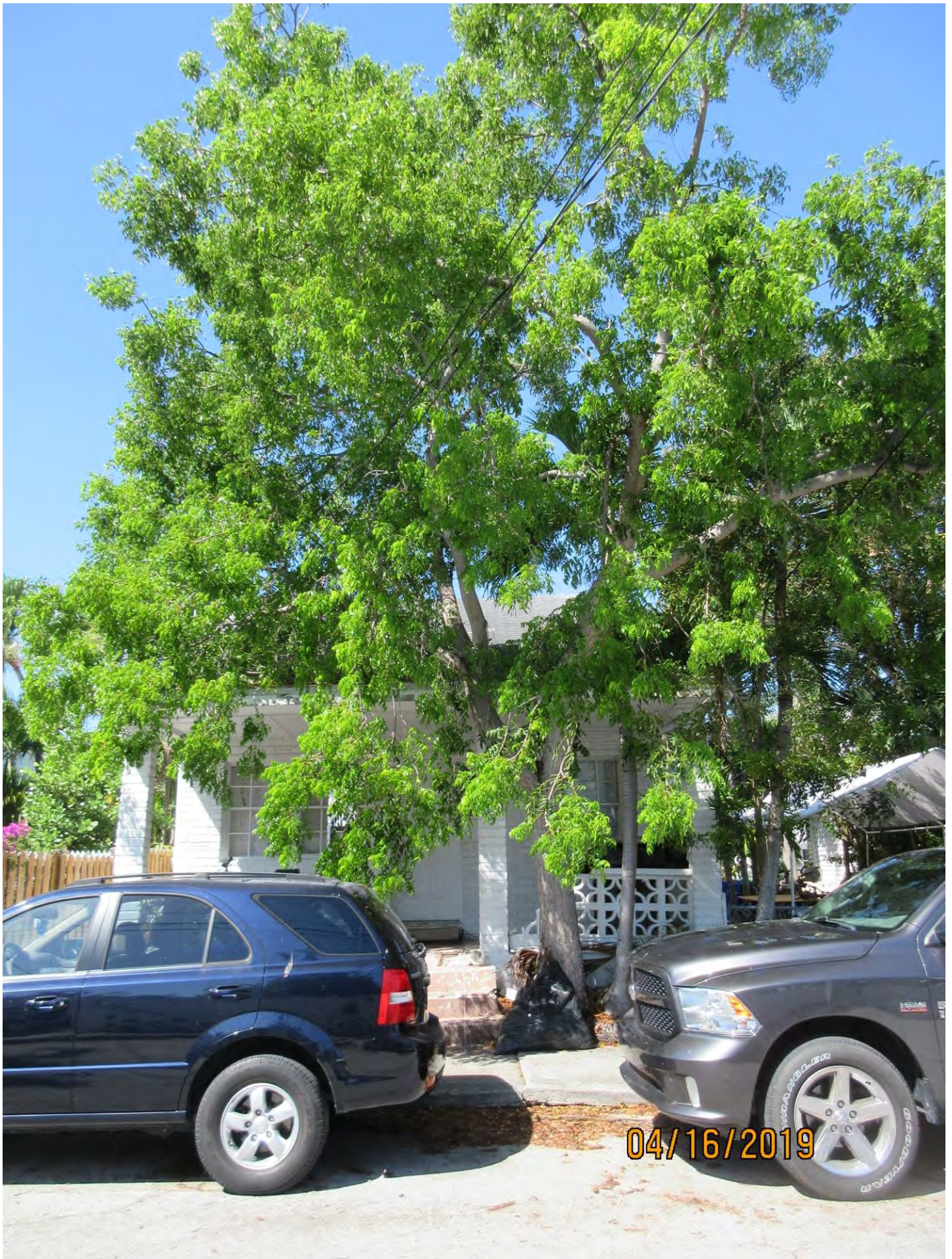

An application was received requesting the removal of **(2) Mahogany trees**. A site inspection was done and documented the following:

Tree Species: Mahogany (Swietenia mahagoni)

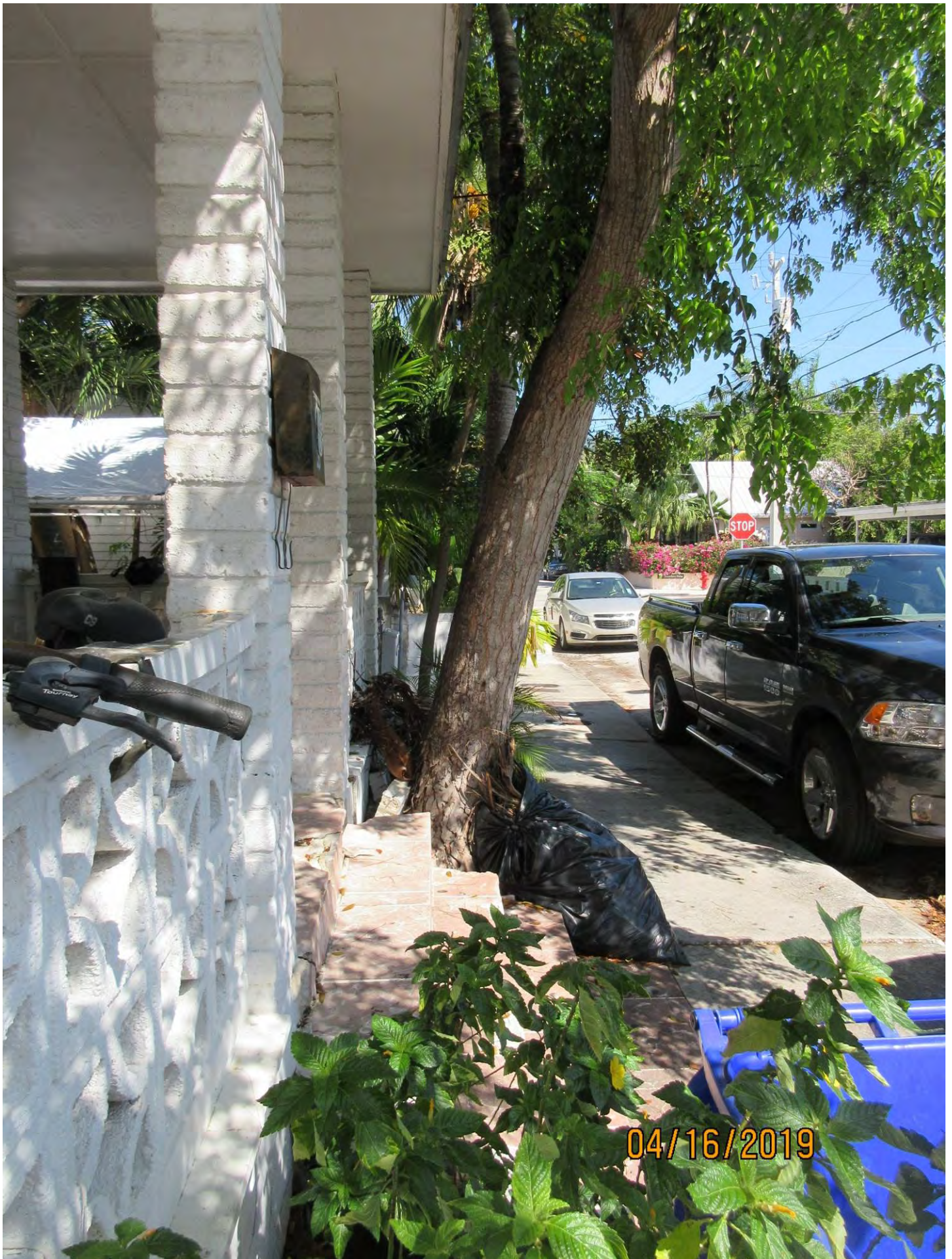

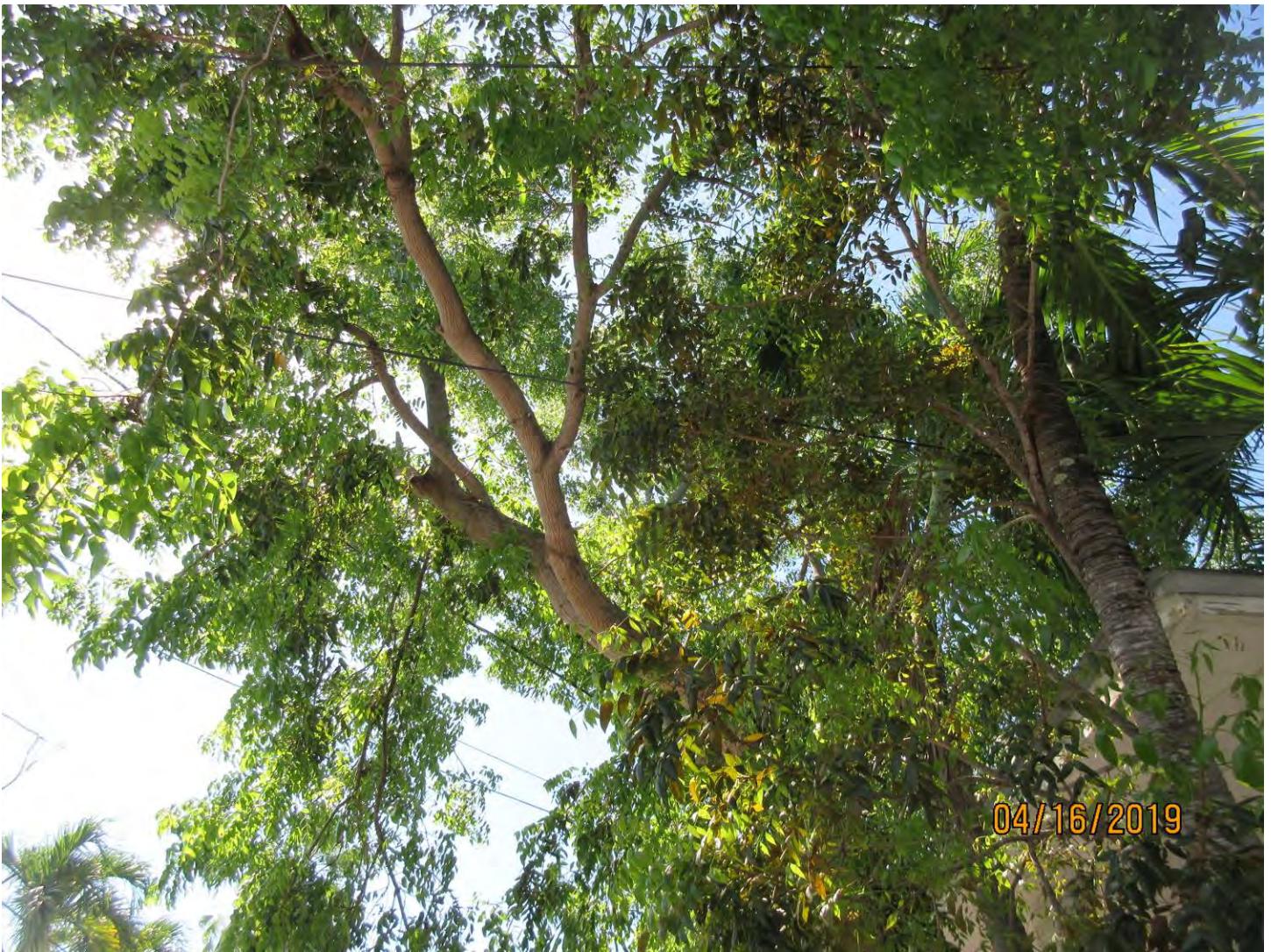

Diameter: 14.3"

Location: 40% (root issue with structure-porch, because of growth toward roadway and away from structure, roots system larger along structure, canopy in utility lines)

Species: 100% (on protected tree list)

Condition: 40% (fair health, poor structure-strong growth lean toward road due to structure)

Total Average Value = 60%

Value x Diameter = 8.5 replacement caliper inches

Location: 50% (wrong tree, wrong place, young tree growing close to porch structure)

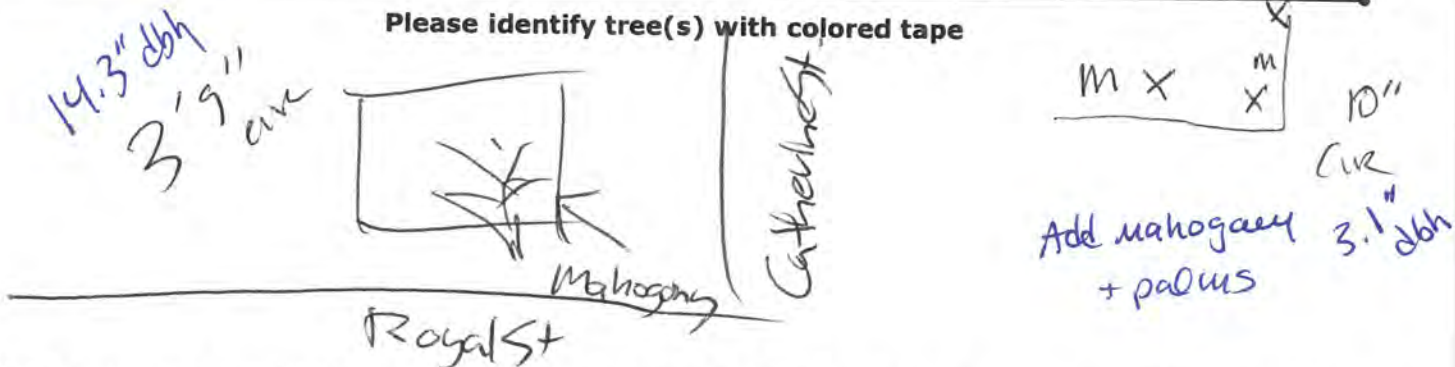

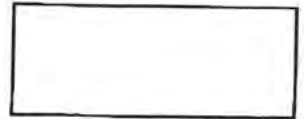
