A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AMENDING RESOLUTION 17-023 TO ADJUST THE PROCUREMENT PRICE AUTHORIZED FOR THE PURCHASE OF TWO (2) GILLIG 29' CLEAN DIESEL BRT LOW FLOOR BUSES, ONE (1) 29' LOW FLOOR BRT HYBRID DIESEL BUS, AND ONE (1) 35' LOW FLOOR BRT CLEAN DIESEL BUS, PLUS LYNX CONTRACT ADMINISTRATIVE FEES OF \$500.00 PER BUS, TO A TOTAL AMOUNT NOT TO EXCEED \$2,040,468.00 PURSUANT TO GOVERNMENT CONTRACT, PURSUANT TO SECTIONS 2-797(3) (a)(b)(c) OF THE CODE OF ORDINANCE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 17-023, the City Commission authorized the purchase of Gillig buses, pursuant to award and acceptance of an FDOT Grant; and

WHEREAS, due to scrivener's error, the procurement price quote has been adjusted to a total of \$2,040,468.00 (from \$2,038,468.00); and

WHEREAS, other terms and conditions of the purchase approved in Resolution 17-023 remain unchanged;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the procurement price for the purchase of up to two (2) Gillig 29' Clean Diesel BRT Low Floor Buses, one (1) 29' Low Floor BRT Hybrid Diesel Bus, and one (1) 35' Low Floor BRT Clean Diesel Bus, plus Lynx Contract Administrative Fees of \$500.00 per bus, previously approved in Resolution 17-023, is hereby adjusted and approved in a total amount not to exceed \$2,040,468.00, pursuant to sections 2-797(1)(3) and 2-844(A) of the Code of Ordinances.

Section 2: Other terms and conditions of Resolution 17-023 shall remain unchanged.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
