A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RENEWING THROUGH JANUARY 31, 2023, THE CONSULTING AGREEMENT FOR THE CORRADINO GROUP, INC., EXTENDED THROUGH RESOLUTION 21-218, PURSUANT TO SECTION 2-797(4) (B) OF THE CODE OF ORDINANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Manager executed a Consulting Agreement with The Corradino Group, Inc., for Professional Planning Services for the period of August 30, 2021 through September 30, 2021 in an amount below the purchasing approval threshold, pursuant to Section 2-771 of the Code of Ordinances

WHEREAS, in Resolution 21-218 the City Commission authorized the City Manager to negotiate a one-year extension for the period of October 1, 2021, through September 30, 2022; and; and

WHEREAS, City staff recommends extending the contract through January 31, 2023 (an additional four months), to allow adequate time for solicitation, review, ranking and award of new competitive bids; and

WHEREAS, the City Manager finds that pursuant to Section 2-797(4){b) of the Code of Ordinances, exceptional

circumstances exist to exempt this procurement from competitive bid requirements in the best interests of the City, and recommends City Commission approval of these contract extensions; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the contract for professional planning services are hereby extended through January 31, 2023 (an additional four months), upon terms identified in the current contract for The Corradino Group, Inc.

Section 2: That the City Manager is hereby authorized to execute a renewal agreement upon agreed terms for the above-described contract through January 31, 2023, upon the advice and consent of the City Attorney.

Section 3: Specific task orders issued pursuant to the contract shall continue to comply with the City's procurement guidelines.

Section 4: That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
