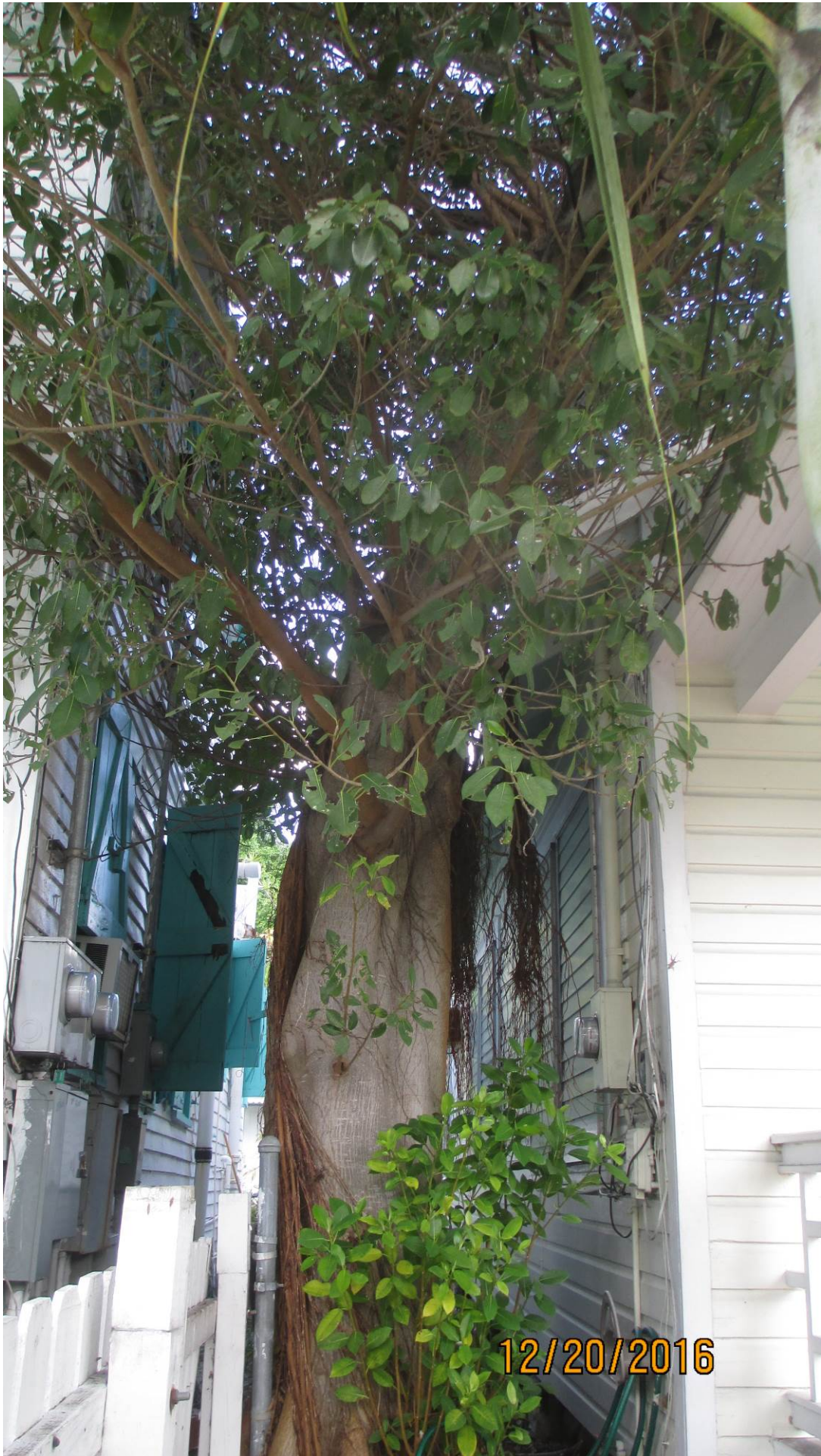

An application was received requesting the removal of **(1) Strangler Fig tree**. A site inspection was done on December 20, 2016 and documented the following:

Tree Species: Strangler Fig (*Ficus aurea*)

Diameter: 22.9"

Location: 30% (close to property line and houses. Growing into electrical feeder lines. WRONG TREE WRONG PLACE-tree species too large for area)

Species: 100% (on protected tree list)

Condition: 50% (fair)

Total Average Value = 60%

**Value x Diameter = 13.7 replacement caliper inches**

**Recommendation: Recommend approval of the removal of one (1) Strangler fig tree at 529 Olivia Street to be replaced with 13.7 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.**

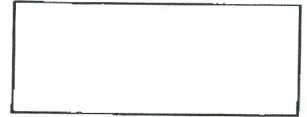
<<<< Sketch location of tree in this area including cross/corner Street >>>>

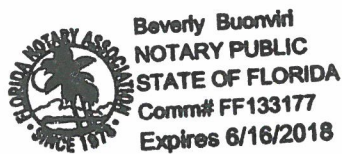
