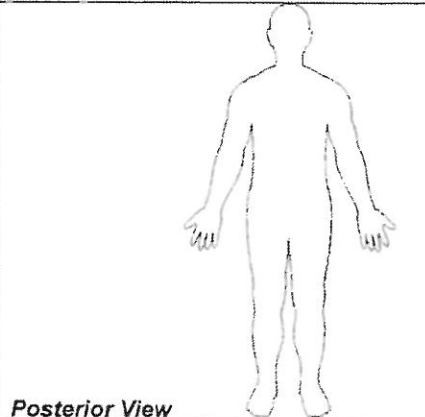

Topic SUPPLEMENTAL

On Wednesday, 04/06/2016, at approximately 2146 hours, I (Ofc. J. HAMMERS) responded to the 500 block of Duval Street to assist Ofc. I. KASYANENKO with an altercation.

Upon arrival, I observed CHRISTOPHER BLAGG sitting on the sidewalk on Southard Street near the Duval Street intersection. BLAGG was in handcuffs. Ofc. I. KASYANENKO placed BLAGG in handcuffs prior to my arrival. I initiated my BWC and in-car Coban system.

I spoke to BLAGG while Ofc. I. KASYANENKO was conducting his investigation. BLAGG was agitated and confrontational. BLAGG repeatedly referred to his Constitutional Rights, and questioned why he was being detained. BLAGG was loud and verbally argumentative. BLAGG appeared intoxicated. BLAGG complained of pain to the left side of his neck. BLAGG refused medical treatment.

Ofc. I. KASYANENKO was speaking to a female that matched the description of a person reportedly involved in a physical altercation. The female was reported as wearing a blue shirt and jean shorts. The female was later identified as ARIANA BARRIENTOS.

Ofc. C. WILLIAMS and Ofc. J. ELSMORE arrived on scene.

I was approached by CYNTHIA WENSINGER while on scene. WENSINGER identified herself as BARRENTOS's mother. WENSINGER said she convened to the area of Duval Street and Southard Street to locate her daughter. WENSINGER said BARRIENTOS and BLAGG had been driving her silver motor scooter prior to the incident (FL Tag 7256RJ). WENSINGER said BARRIENTOS told her BLAGG left her on the ground when the motor scooter fell where it was parked. WENSINGER said she found BARRIENTOS holding BLAGG down in the middle of the street. WENSINGER said BARRIENTOS did not strike BLAGG. WENSINGER said she was told that BLAGG was verbally abusive to BARRIENTOS. WENSINGER said she separated BARRIENTOS from BLAGG.

I spoke to JEREMY SMITH (Witness). SMITH said he walked out of a restaurant on the 400 block of Southard Street to find BARRIENTOS on the ground near a scooter. SMITH said BARRIENTOS was having trouble with the scooter. SMITH said he was helping BARRIENTOS when BLAGG ran over and became verbally aggressive. SMITH said BLAGG then left on his skateboard, and BARRIENTOS chased after him.

I spoke to BRADLEY O. RICE (Witness). RICE said he heard people arguing on the 400 block of Southard Street from the 500 block of Duval Street. RICE said he observed BLAGG and BARRIENTOS arguing near a group of parked scooters. RICE said BLAGG got on his skateboard and headed towards Duval Street. RICE said BARRIENTOS chased after BLAGG, tackled him off his skateboard, and took him to the ground. RICE said BLAGG's skateboard went rolling across Duval Street. RICE said he began filming the altercation. RICE said BARRIENTOS was on top of BLAGG. RICE said BLAGG had his arms extended out to his sides. RICE said BLAGG did not strike BARRIENTOS. RICE said BARRIENTOS was holding BLAGG down. RICE said he observed BARRIENTOS strike BLAGG several times with her fist. RICE provided me with his information. RICE said he witnessed majority of the altercation. RICE showed me the video of the altercation on his cell phone. RICE said he would send me the footage via e-mail.

On Rice's call phone video, I observed the following:

BARRIENTOS could be seen mounting BLAGG and holding him down on the asphalt. WENSINGER walked into the frame, grabs BARRIENTOS's left arm, and attempted to pull BARRIENTOS off of BLAGG. As BARRIENTOS was being pulled off of BLAGG, using her clinched right fist, she attempted to strike BLAGG several times. I was unable to determine how many times BARRIENTOS made physical contact with BLAGG.

At this time, I have yet to receive RICE's e-mail containing the video of the altercation.

While collecting information for Ofc. I. KASYANENKO, I observed BARRIENTOS becoming agitated and challenging Ofc. I. KASYANENKO. BARRIENTOS was acting belligerent. Ofc. I. KASYANENKO told BARRIENTOS to go with her mother (WENSINGER) and leave. WENSINGER was unable to control BARRIENTOS when she attempted to help her leave. BARRIENTOS pulled away from WENSINGER and repeatedly approached Ofc. I. KASYANENKO. Ofc. I. KASYANENKO asked Ofc. C. WILLIAMS and I to place BARRIENTOS into custody in reference to a Marchman Act. Ofc. C. WILLIAMS grabbed BARRIENTOS's left arm. Immediately I could see BARRIENTOS tense up, and attempt to pull away from Ofc. C. WILLIAMS's control. I grabbed BARRIENTOS's left arm while Ofc. C. WILLIAMS controlled her right. BARRIENTOS repeatedly pulled her body away from our control, and physically resisted our attempts to place her in handcuffs. BARRIENTOS was eventually placed in handcuffs. BARRIENTOS continuously pulled away. I placed my left foot on the inside of BARRIENTOS's right foot to attempt to gain control of her person, and prepare for a search by Ofc. C. WILLIAMS. Ofc. C. WILLIAMS and I escorted BARRIENTOS to my patrol vehicle, all the while she continued to pull away from our control, and began screaming. BARRIENTOS physically resisted to walk to my patrol vehicle. It took several minutes to place BARRIENTOS into the rear of my patrol vehicle because she physically resisted to sit down. BARRIENTOS locked her body and refused to get in the back seat of my vehicle. Ofc. C. WILLIAMS and I were eventually able to get BARRIENTOS in my patrol vehicle with the assistance of Ofc. I. KASYANENKO. While in my vehicle, BARRIENTOS was able to take her left hand out of handcuffs. BARRIENTOS was loud, agitated, and aggressive. BARRIENTOS appeared intoxicated and had a strong odor of an alcoholic beverage emitting from her person. After a second time of removing her hand from the handcuffs, BARRIENTOS was taken out of the car to be permanently secured in handcuffs. While standing outside of my vehicle, BARRIENTOS complained of pain to her left knee. BARRIENTOS began accusing me of kicking the back of her leg. BARRIENTOS suddenly without being provoked, dropped to the ground. I placed BARRIENTOS in the back seat of my patrol vehicle. BARRIENTOS requested medical attention. KWFD Rescue arrived on scene. Sgt. D. BARRIOS arrived on scene to document BARRIENTOS alleged injury she claimed to have sustained from KWPD. BARRIENTOS was transported to LKMC by KWFD with the assistance of Ofc. C. WILLIAMS.

I had no further involvement with this case. See Ofc. I. KASYANENKO, Ofc. C. WILLIAMS, and Ofc. J. ELSMORE's reports for further information.

	1 On April 6, 2016, at approximately 2150 hours, Ofc. C. Williams and I were dispatched to Southard St. and Duval St. in reference to a verbal altercation.	
	Upon arrival, I observed a white male sitting on the sidewalk handcuffed behind the back and Ofc. Igor talking to Ariana Barrientos and another white male. I also observed Ofc. J. Hammers talking to three individuals next to the detained male.	
	As I approached the detained male, I observed he had multiple lacerations to his neck and his shirt was ripped at the collar. The detained male repeated multiple times his rights were being violated and he did nothing wrong. The detained male became belligerent and for officer safety Ofc. I. Kasyanenko and Ofc. C. Williams relocated the male to the back of a patrol vehicle that was on scene.	
	As the male was being detained to the back of the patrol vehicle, Ariana began to raise her voice and become disorderly. Ariana was asked multiple times to calm down and step to the side while Ofc. I. Kasyanenko investigates the situation. Ariana refused to step aside and did not want to calm down. Ofc. J. Hammers and Ofc. C. Williams tried to separate Ariana from the patrol car where the detained male was located, but Ariana refused to move. At the moment, Ofc. J. Hammers and Ofc. C. Williams tried to move Ariana from the scene and she began to resist by turning and pushing herself away from the officers. The officers tried to control Ariana by holding her arms and assisting her away from the scene but Ariana refused to comply with the officer's verbal commands.	
	Ofc. J. Hammers and C. Williams tried to detain Ariana at that point, but Ariana continued to resist by pushing and turning away from the officers as they gave verbal commands to stop resisting. The officers continuously gave Ariana verbal commands to stop resisting and place her hands behind her back. After a couple minutes of struggle with Ariana the officers were able to handcuff Ariana behind her back.	
	I stayed with the detained male while the officers escorted Ariana to the back of the patrol vehicle on scene. I observed Ariana resisting the officers at the patrol vehicle and refused to get in the back seat. I also observed Ofc. I. Kasyanenko, Ofc. C. Williams and Ofc. J Hammers using controlling methods to get Ariana to comply with their commands but Ariana continued to resist.

After a couple minutes of struggle, Ariana was detained in the back seat of the patrol vehicle. Ariana was able to slip her wrists out of the handcuffs in the back of the patrol vehicle. In an attempt to re-handcuff Ariana, I asked her to step out of the vehicle. Once Ariana stepped out of the vehicle, she dropped to the floor and stated her left leg was injured. Ariana stated she was unable to stand on her left leg because an officer caused this injury by kicking her in the back of her leg. Rescue was called to the scene and Ariana was escorted to the ER. I followed rescue to the ER and stayed with Ariana for the duration of medical assistance. While Ariana was being treated at the ER she was being belligerent towards the medical staff. Ariana was not cooperative and disagreed with the treatment they offered. Upon being released from the ER Ariana began to hit the wall multiple times with her fists. Ariana was cleared from the ER with no injuries and I escorted her to MCDC. BWC was on throughout the investigation. End of Narrative: 1

Barrientos said "I'm inebriated, I don't give a fuck", she said she was going to be honest. Barrientos said as she was parking her scooter it fell on her. Barrientos indicated that it was the reason she had injuries on her knees. Barrientos said some random guy, came up to help her out and Blagg got jealous. Barrientos said she got mad and took Blagg "down". Barrientos at first said she was not sure where the scratches came from, but then said it could possibly be from her, as she was grabbing Blagg.

Barrientos' statement was captured on my BWC.

It was determined that Blagg and Barrientos both live together in Blagg's van and have been dating for approximately 4 months.

Blagg did not want to cooperate during the investigation and refused to take pictures or give any statements.

Both Barrientos and Blagg had an overwhelming odor of an alcoholic beverage on their person and blood shot eyes. I also noticed that Barrientos had a slurred speech.

Multiple witnesses informed Ofc. Hammers that Barrientos was on top of Blagg and smacked him numerous times. One of the witnesses produced a video from a smart phone, documenting the attack by Barrientos. (See Ofc. Hammers supplemental report for details)

I spoke with another witness on the phone, that actually called the police when the fight had occurred and later left the scene. The witness did not want to meet, but did corroborate the same thing that other witnesses stated. In addition he added that Blagg did not fight back when Barrientos was attacking him.

I informed Barrientos that Blagg was going to be transported to MCDC in reference to the Marchman Act. Barrientos became uncooperative and disorderly. I indicated to Ofc. Hammers and Ofc. Williams that Barrientos was going to be detained. Ofc. Williams attempted to secure Barrientos' wrists to handcuff her. Barrientos resisted Ofc. Williams efforts to apply handcuffs by pulling her arms away; tensing her arms; tensing her hands; tensing her body; turning her torso into her; and turning her torso away from her. Officer Hammers also attempted to gain control of Barrientos, but she continue to resist and prevent them obtaining lawful physical control. Officer Hammers and Ofc. Williams struggled to escort Barrientos to the patrol car due to her resistant behavior. Barrientos slipped her wrist out of a handcuff. Barrientos refused to get inside the patrol vehicle. After many attempts to place her inside the vehicle, Barrientos continued to resist. I got inside the rear passenger compartment of the patrol vehicle and managed to pull her into the vehicle. I did so by pulling one of her arms and applying pressure with my foot to the back of her knee, attempting to collapse her into a seated position inside the car. I was able to pull Barrientos inside and secure her in the vehicle.

Barrientos managed to slip one of her wrists out of the handcuffs while in the vehicle. I had to assist Ofc. Williams and Ofc. Hammers in putting the handcuffs back on her.

I then transported Blagg to MCDC reference Marchman Act.

While en route to MCDC, I overheard one of the Officers requesting Rescue, due to Barrientos complaining about an injury.

I had the bathroom door cracked slightly open for safety reasons. It appeared Ariana had completed her usage of the bathroom because she washed her hands and was walking towards the door. I opened the door more to allow her to exit. Ariana had taken her shorts off and was naked from the waist down. I closed the door and directed Ariana to put her clothes on.

Ariana resisted as Ofc. Elsmore and I attempted to escort her back to her hospital room. After being medically released, Ariana began punching the wall repeatedly (she was still handcuffed in the front for ease of using the bathroom). She resisted my and Ofc. Elsmore attempts to escort her out of the ER. I requested an additional backup officer. Officer Elsmore and I struggled to escort her to the patrol vehicle due to her resistance. I transported her to the jail for processing.

My body cam was on until the battery died while at the ER. Nothing further to report.
