A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING RACE WORLD OFFSHORE, LLC TO CONDUCT A CONCERT ON THURSDAY, NOVEMBER 7, 2024, FROM 6:00 P.M. TO 10:00 P.M. AT THE TRUMAN WATERFRONT COFFEE BUTLER AMPHITHEATER, A STREET CLOSURE ON GREENE STREET FROM DUVAL TO ANN STREET ON THURSDAY, NOVEMBER 7, 2024, FROM 6:00 P.M. TO 10:00 P.M., A STREET CLOSURE FROM FRONT STREET TO SOUTHARD STREET AND FITZPATRICK TO SIMONTON STREET ON FRIDAY, NOVEMBER 8, 2024, FROM 6:00 P.M. TO 10:00 P.M., A CONCERT ON SATURDAY, NOVEMBER 9, 11:00 A.M. TO 10:00 P.M. 2024, **FROM** AT THE **TRUMAN** WATERFRONT COFFEE BUTLER AMPHITHEATER AND AN AWARDS CEREMONY ON SUNDAY, NOVEMBER 10, 2024, FROM 3:00 P.M. 10:00  $\mathbf{AT}$ THE **TRUMAN** WATERFRONT COFFEE AMPHITHEATER; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY **MANAGER**; AUTHORIZING THE SALE **AND CONSUMPTION OF** ALCOHOLIC **BEVERAGES** WITHIN THE BARRICADED AREA DURING EACH EVENT; PROVIDING FOR AN **EFFECTIVE DATE** 

**NOW THEREFORE, BE IT RESOLVED,** by the City Commission of the City of Key West, Florida.

**SECTION 1.** That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

**SECTION 2.** "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

**SECTION 3.** That Race World Offshore, LLC is hereby granted permission to conduct numerous events on the days and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; provided the organization meet the terms and conditions set forth by the City Manager.

**SECTION 4.** That the Race World Offshore, LLC. is hereby granted permission the use of the "Truman Waterfront Coffee Butler Amphitheater".

**SECTION 5.** That the Race World Offshore, LLC. will submit to the City of Key West a rental fee agreed upon the City Manager plus tax.

**SECTION 6.** That pursuant to Section 18-86 of the Key West Code of Ordinances, permission is granted to allow the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 7.** That the Race World Offshore, LLC must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

**SECTION 8.** That the Race World Offshore, LLC will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

**SECTION 9.** That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
