A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED ART IN PUBLIC PLACES BOARD SELECTIONS FOR DOUGLASS GYM AND COMMUNITY CENTER PUBLIC ART IN RESPONSE TO RFP #007-19; AUTHORIZING THE CITY MANAGER TO NEGOTIATE IF NECESSARY, AND EXECUTE AGREEMENTS UPON CONSENT OF THE CITY ATTORNEY BETWEEN THE CITY OF KEY WEST AND THE FOLLOWING TWO ARTISTS: McMOW GLASS (TARGETED SPACE #1 EXTERIOR/INTERIOR MOSAIC ART GLASS VIGNETTES IN THREE LOCATIONS -- \$25,000.00), JH ALLEN (TARGETED SPACE INTERIOR #4 CEILING TRUSSES FOR BANNERS \$14,400.00); AUTHORIZING NECESSARY BUDGET ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, RFP #007-19, was advertised on February 16, 2019, and 13 proposals were received in response to the RFP on April 17, 2019. Of the 13 proposals, 11 were determined to be responsive and responsible; and

WHEREAS, the Art in Public Places (AIPP) Board, along with two non-voting members appointed by the City Manager, acted as the Selection Ranking Committee and considered at a public meeting the 11 responsive proposals on April 24th, 2019, ranking the projects pursuant to a process set forth in the RFP package; and

WHEREAS, the AIPP Board recommends City Commission approval of the two highest-ranked projects for specific sites, as set forth in this Resolution; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Art in Public Places Board Selection Committee's recommended ranking and selections for site-specific, commissioned, original and permanent public art for the Douglass Gym and Community Center are hereby approved in Response to RFP #007-19.

Section 2: That the City Manager is authorized to negotiate (as necessary) and execute contracts in substantial conformance with the RFP and recommendations of the AIPP Selection Committee, upon consent of the City Attorney, for the two artists/proposals as follows:

1. McMow Glass (Targeted Space #1: Exterior/Interior Mosaic Art Glass Vignettes in three locations -- \$25,000.00).

2. JH Allen (Targeted Space Interior #4 Ceiling Trusses for Banners \$14,400.00)

Section 3: That funds for these art projects are budgeted as the Percent for Public Art component of the reconstruction of Douglass Gym and Community Center. A budget adjustment in the amount of \$400.00 is authorized, and funds in the total amount of \$39,400.00 will be transferred from AIPP Reserves to Fund 110/AIPP - Works of Art Account No. 110-5902-559-67.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
