A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF AMERICAN UNDERWATER CONTRACTORS, INC. IN RESPONSE TO ITB #17-001 IN THE AMOUNT OF \$69,772.00 FOR MOORING FIELD ANCHOR HEAD REPLACEMENT - CITY MARINA AT GARRISON BIGHT; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN ITB #17-001, UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, two responsive bids were received on November 16, 2016, in response to ITB #17-001, for the replacement of helical anchors/heads at the Mooring Field; and

WHEREAS, American Underwater Contractors, Inc. submitted the lowest responsive bid in response to ITB #17-001;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of \$44,852.00, plus 35 additional anchors at \$24,920.00, of American Underwater Contractors, Inc. in response to ITB #17-001 for Mooring Field Anchor Head Replacement

= City Marina at Garrison Bight, is hereby awarded at a total price of \$69,772.00.

Section 2: That the replacement of additional anchor heads, at the contractual rate of \$712 each is authorized, so long as the total project cost does not exceed budgeted funds.

Section 3: That funds in the amount of up to \$90,000.00 are budgeted for Garrison Bight Mooring Field Repairs and Maintenance in account 413-7554-575-4600.

Section 4: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained in ITB #17-001, upon advice and consent of the City Attorney.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
