A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "FIRST AMENDMENT TO TEMPORARY USE LEASE AGREEMENT FOR A HOMELESS SAFE ZONE" BETWEEN MONROE COUNTY FLORIDA ("County") AND THE CITY OF KEY WEST ("City"); AUTHORIZING NECESSARY BUDGET AMENDMENTS OR ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City and the County have collaborated over decades to address the issue of safe housing for the homeless population of Key West and Monroe County; and

WHEREAS, in October 2022, the City, County and the Monroe County Sheriff entered into a two-year Temporary Lease Agreement to establish a Temporary Keys Homeless Safe Zone, while a new shelter is being built; and

WHEREAS, the parties find that an extension of the Agreement is in the best interests of the public, while construction of the "John Jones Navigation Center" is completed; and

WHEREAS, the attached First Amendment to Temporary Use Lease Agreement for a Homeless Safe Zone will help protect the health, welfare and safety of citizens of Key West and Monroe County; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "First Amendment to Temporary Use Lease Agreement for a Homeless Safe Zone" between the City and County is hereby approved.

Section 2: That necessary budget amendments and/or adjustments are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
