A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ASSIGNEMENT OF THE CONTRACT FOR INDEPENDENT AUDITING SERVICES BETWEEN THE CITY AND KEEFE McCULLOUGH & CO., LLP TO CITRIN COOPERMAN & COMPANY, LLPON THE SAME TERMS AND CONDITIONS; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS CONSISTENT UPON THE ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Keefe McCullough & Co., LLP was acquired through an Attest Asset Purchase Agreement by Citrin Cooperman & Company, LLP on February 1, 2024; and

WHEREAS, in accordance with Florida Statutes 218.391, City staff recommends the assignment of the contract for Independent Auditing Services with Keefe McCullough & Co., LLP to Citrin Cooperman & Company, LLP upon the same terms and conditions of the current contract; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an assignment of the City's contract with Keefe McCullough & Co., LLP for Independent Auditing Services, which was awarded in accordance with Florida Statutes 218.391, to Citrin Cooperman & Company, LLP, on the same terms and conditions, is hereby approved.
