A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S GENERAL UTILITIES SERVICES CONTRACT WITH D.N. HIGGINS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$32,304.30 FOR REPAIRS TO THE ATLANTIC BOULEVARD MULTI-USE PATH FROM REST BEACH TO BERTHA STREET; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-292, the City Commission approved a three-year General Utilities Services contract with Douglas N. Higgins, and in Resolution 18-322 the contract was extended for two years; and

WHEREAS, the Atlantic Boulevard multi-use path requires repair of buckled pavement. The removal of certain tree roots has been authorized by the Urban Forester, and the southwest corner of Atlantic Boulevard and Bertha Street will be releveled and resurfaced; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That a Task Order for Repairs to the Atlantic Boulevard Multi-Use Path from Rest Beach to Bertha Street, under the City's General Utilities Contract with Douglas N. Higgins, Inc., is hereby approved in an amount not to exceed \$32,304.30.

Section 2: That funds for this project will be paid from Infrastructure Fund Account #102-4102-541-6300, and any necessary budget adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute necessary documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
