I called Wayne Garcia regarding the application explaining the application was not complete and reminded him work could not begin until he had the permit in hand. I went by the property and spoke to Keith Kleppinger. Brownie Companies, LLC. had removed a fence and was shoring the house. They stated Wayne Garcia had the permits. I explained the job could not begin until permits were paid for and picked up. I placed a 2nd STOP WORK ORDER ON THE PROPERTY. Pictures will be in optiview."
