A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING AN INCREASE TO PURCHASING EXCEPTION PURSUANT TO SECTION 2-797(4)(b) OF THE CODE OF ORDINANCES, TO ALLOW AN INCREASE NOT TO EXCEED \$4,000.00 IN CUMULATIVE EXPENDITURES DURING FY 18-19 TO MONROE CONCRETE PRODUCTS, INC. (FROM \$30,000.00 TO \$34,000.00); AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS OR TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, Monroe Concrete Products provides concrete for City sidewalk repairs, which have required more repairs than anticipated this year to protect public safety and welfare; and

WHEREAS, the City Manager finds that pursuant to code of ordinances section 2-797(4)(b) best interest of the City, it is appropriate adjust the amount of authorized expenditures previously approved (\$30,000.00), by increasing the purchasing exception for Monroe Concrete Products by \$4,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That an increase to expenditures in the amount of \$4,000.00 is hereby approved for Monroe Concrete Products, Inc. in accordance with Key West City Code of Ordinances section 2-797(4)(b), bringing the blanket purchase order to a total of \$34,000.00.

Section 3: That a transfer in the amount of \$4,000.00 from Internal Improvements Fund/Sidewalks/Repairs and Maintenance 102-4104-541-4600 to the blanket purchase order for Monroe Concrete Products, Inc. is hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
