An application was received requesting the removal of **(1) Mango Street**. A site inspection was done on December 15, 2015 and documented the following:

Tree Species: Mango (*Mangifera indica*)













Diameter: 13.6"

Location: 30%

Species: 100% (on protected tree list)

Condition: 50% (fair)

Total Average Value = 60%


**Value x Diameter = 8 replacement caliper inches**

**Recommendation: Recommend approval of the removal of one (1) Mango tree at 1116 Packer Street to be replaced with 8 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted onsite.**



**Note: Two Ficus benjaminia trees located in the front yard are to be removed, no permit is required for their removal as this tree species is not regulated.**


