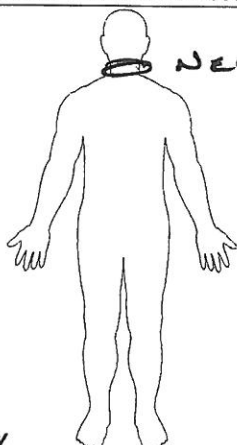

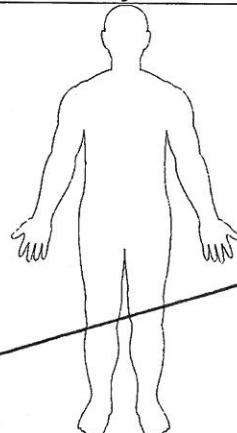

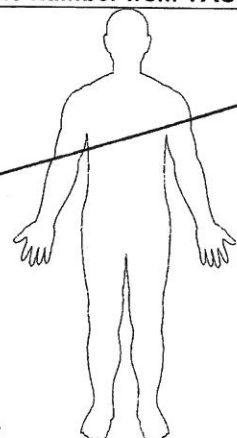

motorcycle and also was not wearing any eye protection while operating the motorcycle. I yelled to Davis to get his attention but he did not hear me because of the revving of the engine. Davis made a u-turn in front of 406 Duval St., and proceeded south towards my location. I stepped out in front of Davis and had him pull over. I initiated a traffic stop on Davis for the above violations.

I asked Davis for a valid license. Davis said he did not have it with him. I asked Davis if his license was valid and he just didn't have it with him. Davis said, yes, his license was good. Davis also said he had a valid motorcycle endorsement. Davis provided me with his name and date of birth. I ran Davis' information through FCIC/NCIC. KWPD Dispatch advised me, Davis' had an active arrest warrant, (MCSO Case # MCSO15OFF006313) reference traffic offenses.

I walked to Davis and took hold of his left hand. I told Davis to drop a cigarette he was holding. I told Davis not to do say anything stupid or he would be "Tased. I placed one handcuff on Davis's left hand and had him step off the motorcycle. The motorcycle's kickstand was not properly set, so it fell over. I attempted to take a hold of Davis' right hand, but he pulled his right hand into his body, thwarting my efforts to handcuff him. I told Davis to get on the ground, and that he had a warrant. Davis continued to tense his right arm, resisting my efforts in handcuff him. I turned my body and while still holding Davis' left hand and arm I guided him to the ground. While Davis was resisting arrest, he had knocked off my Body Worn Camera (BWC) to the ground. The BWC hit the ground and shut off. While on the ground I was able to secure both of Davis' hands in handcuffs. With the help of a citizen, who identified himself as an off-duty law enforcement officer, we stood Davis to his feet.

Ofc. Blanco arrived on scene.

KWPD Dispatch advised Davis did not posses a valid Florida driver's license, but only an ID card. KWPD Dispatch advised Davis did not possess a motorcycle endorsement.

Ofc. Blanco conducted a search of Davis' person. Ofc. Blanco removed a black wallet from Davis' pants pocket. When the wallet was opened, a authentic gold badge belonging to a Correction Deputy from the Monroe County Sheriff's Office was displayed. In the middle of the wallet showed a Monroe County Sheriff's Office business card belonging to a Sgt. Chuck Kellenberger of the Monroe County Sheriff's Office. The badge and card were placed in the wallet the same way an actual police officer or sheriff's deputy would display it. I confirmed with the Monroe County Sheriff's Office that Davis is currently or had never been employed with the Monroe County Sheriff's Office.

Ofc. Blanco had placed Davis in the rear of his patrol vehicle. Ofc. Blanco began to complete criminal traffic citations for Davis. I asked Davis if had been injured and if he wanted Key West Rescue. Dais said his neck and back were injured and he wanted rescue.

I contacted Sgt. Rodriguez who arrived on scene, reference response to resistance.

I explained to Sgt. Rodriguez what had occurred during the incident and showed him the badge and ID card. Sgt. Rodriguez made contact with Davis and advised Davis of his Miranda Rights. Davis waived his rights and agreed to speak to Sgt. Rodriguez about the MCSO Correction Deputy badge. Sgt. Rodriguez told me, Davis said, a deputy had given it to him, but he would not say who it was. Later on during the investigation, Davis said a deputy did not give him the badge, but Dr. Covington had given it to him. I will subsequently place the badge into KWPD Property and Evidence for further investigation.

Key West Rescue 2 arrived on scene and removed Davis from the patrol vehicle. Due to Davis' claim of neck and back injury. They placed him on a backboard and placed a neck collar around his neck. Davis was placed into the ambulance. I rode with Key West Rescue to Lower Keys Medical Center. I photographed Davis's person. I photographed a cut on Davis' left shin. The cut appeared to be an old scab, which was opened up by the nylon belt from the backboard. Once at the emergency room, Davis said he wasn't injured anymore, and he wanted to leave and go to jail. The hospital released Davis upon his refusal of any medical attention.

Ofc. Blanco transported Davis to the Monroe County Detention Center.

During the investigation, I learned that Deputy Bragg had stopped Davis, on 10/10/2015, for not wearing eye protection. I learned from Deputy Bragg's report that Davis told Deputy Bragg he had a license in the state of Alabama and a motorcycle endorsement out of Arizona. Deputy Bragg at the time, could only confirm Davis had a valid ID card from Florida but was unable to get a valid return from Arizona and Alabama, so Deputy Bragg had Davis park the motorcycle and had someone pick him up, releasing him pending an investigation.

On 10/13/2015, Deputy Bragg received information from the Arizona Department of Motor Vehicles advising Davis' driving privileges had ben suspended since 2005 and showed motorcycle endorsement. Deputy Bragg also confirmed Davis had a valid license and ID card out of Alabama, but no motorcycle endorsement. KWPD Dispatch advised me that Davis' driving privileges, were in fact, suspended in Alabama.

Deputy Bragg had a criminal history check done for Davis. It showed convictions in Monroe County on 12/13/2012 and 10/31/2012 for DWLS and operating a motorcycle without proper enforcement. The criminal history showed a conviction in Arizona, on 10/04/2005, for DWLS. It also showed a felony conviction on 09/04/2008 in Arizona for Aggravated Driving Under the Influence (DUI) while license suspended for DUI.

During the investigation, Davis told me he had two prior convictions for DWLS with knowledge.

Based on the facts and evidence, I believe there is probable cause, that on 10/29/2015, Daniel Glen Davis did knowingly and intentionally operate a motor vehicle while license suspended/revoked 3rd subsequent offense in violation of FSS 322.34 (2)(c) by having a suspended Arizona driver's license and 3 prior convictions.

Based on the facts and evidence, I believe there is probable cause, that on 10/29/2015, Daniel Glen Davis did knowingly and intentionally operate a motorcycle while not having an endorsement to operate a motorcycle on his suspended Arizona driver's license, suspended Alabama driver's license and Florida ID card.

Based on the facts and evidence, I believe there is probable cause, that on 10/29/2015, Daniel Glen Davis did knowingly and intentionally operate a motor vehicle while not having or ever acquiring a valid drier's license in the State of Florida in violation of FSS 322.03 no driver's license never had one issued.

Based on the facts and evidence, I believe there is probable cause, that on 10/29/2015, Daniel Glen Davis did knowingly and intentionally pull his arm away and tense up while I was attempting to handcuff him for the MCSO warrant violating FSS 843.02 resist officer without violence.

I issued Davis three criminal citations, for the above offenses. Davis is to appear before the Honorable Judge Miller, on 11/06/2015, at 0830 hours, at 302 Fleming St.

Davis signed all three criminal citations.
