Re: Imposing Stormwater Service Assessments against certain real property within the City of Key West; Approving the Stormwater Assessment Roll for the Stormwater Service Assessments; City Commission Meeting – September 3, 2014
Agenda Item 30; Objection to Assessment by real property owners and tenants

Dear Mayor Cates,

The purpose of this letter is to inform the Commission of the objections, held by the attached list of Key West property owners and long-term lessees, to the proposed assessment of non-ad valorem “Stormwater Service Assessments” for properties located within the City of Key West. While the legislative declarations in the City’s proposed resolution provide that the use of an annual special assessment is “an equitable and efficient method of allocating and apportioning the cost...” of stormwater management service, the proposed assessment scheme and the disparate and detrimental impacts that would flow from its application would render the assessment contemplated by the Commission not only inequitable, but unlawful.

The more than 1,700 parcels identified in the attached list all have two things in common: First, they all fall within the City’s proposed “Stormwater Service Area” and would be subject to non-ad valorem assessments. Second, the City currently provides – and under the proposed resolution would continue to provide – absolutely no stormwater management services to their property.

Each listed parcel is situated either along a State of Florida roadway – for which the Florida Department of Transportation provides maintenance of stormwater systems which serves the parcel – or along private roadways that do not use or burden the City’s stormwater management system. After more than two years of construction on North and South Roosevelt Boulevard for the installation of stormwater infrastructure by the Florida Department of Transportation, this Commission should be well aware that properties along North and South Roosevelt Boulevard do not use the City’s stormwater system. The City does not own, maintain, or repair stormwater collection or treatment systems on any of the roads that serve the properties on the attached list. None of these parcels rely on municipal stormwater systems to collect or treat the stormwater


runoff they generate. Under the proposed resolution, however, each of these property owners would be responsible for paying the City's stormwater assessment.

Such an arrangement is clearly not equitable. Further, the imposition of such assessments on these property owners is not legally justifiable. In order for an assessment on a parcel to stand under Florida law, the assessment must be based on the parcel's relative contribution to the need for the service provided. These parcels rely exclusively on stormwater management systems separate and distinct from those provided by the City for the treatment and collection of the stormwater they generate, and the City provides no specific benefit to these properties by its provision of wastewater services on roads owned and controlled by the City.

Under Florida Statutes §403.031(17), a "stormwater utility" means the funding of a stormwater management program to the beneficiaries or users of the system based on their relative contribution to the need for the stormwater system. Florida Statutes §403.0893 provides that areas "which receive substantially different levels of stormwater benefits" shall be assessed different per acreage fees based upon "a reasonable relationship to benefits received." The parcels in the attached list receive no benefit from the City's stormwater collection and treatment. Based on the complete and total absence of a benefit, the parcels should bear no portion of the City's stormwater expenses.

Accordingly, on behalf of the attached property owners, my firm objects to the imposition of the stormwater service assessment roll as it pertains to their properties. There is no legal basis for the imposition of assessments to parcels which rely solely on private or state stormwater systems for collection and treatment of runoff, and such an assessment scheme places an unjust and costly burden on many parcels which stand to derive no benefit from the City's stormwater services.
