2. Hawk Missile Site

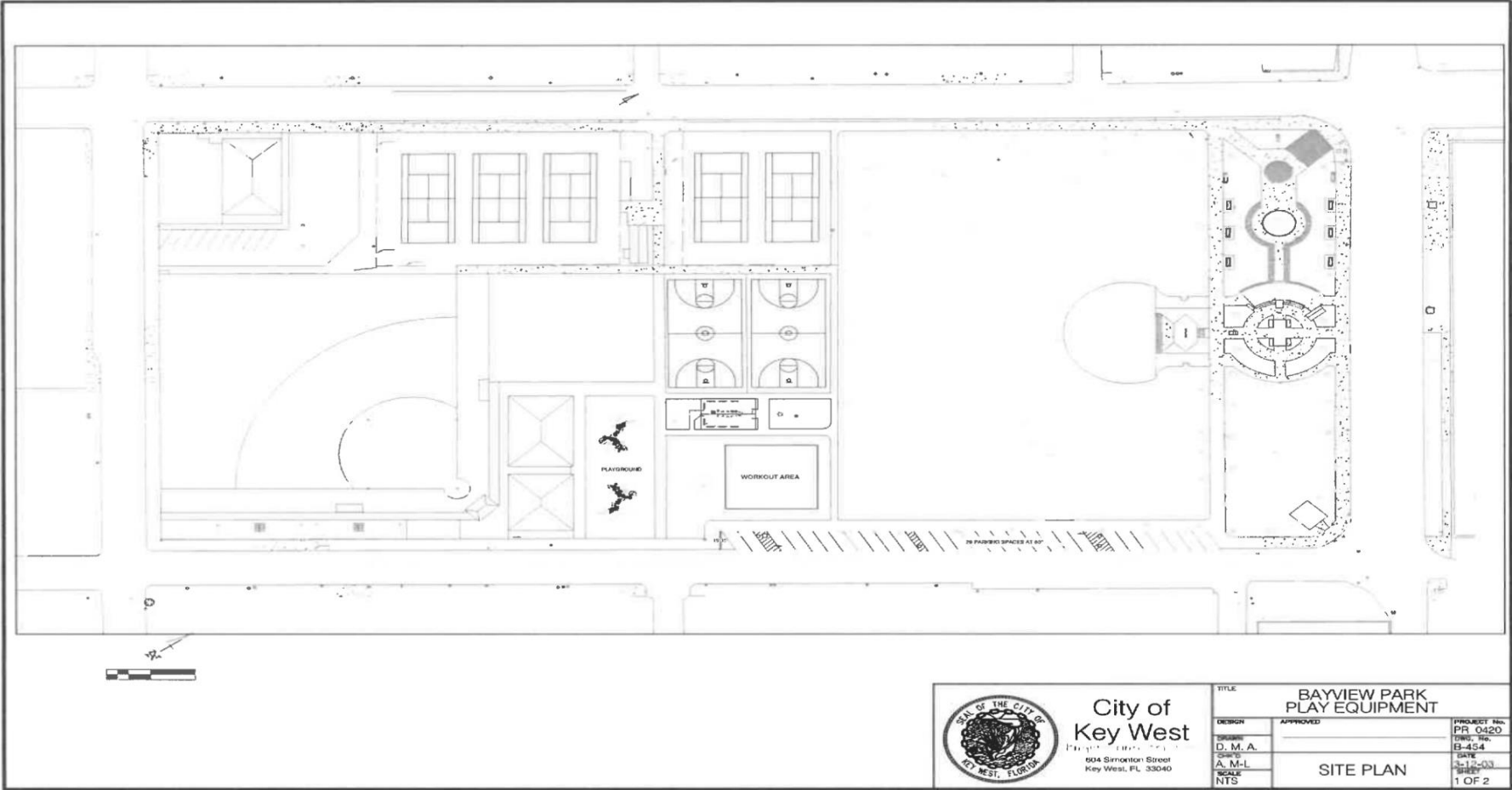
- Establish short, intermediate and long term goals

3. Current/Ongoing Projects

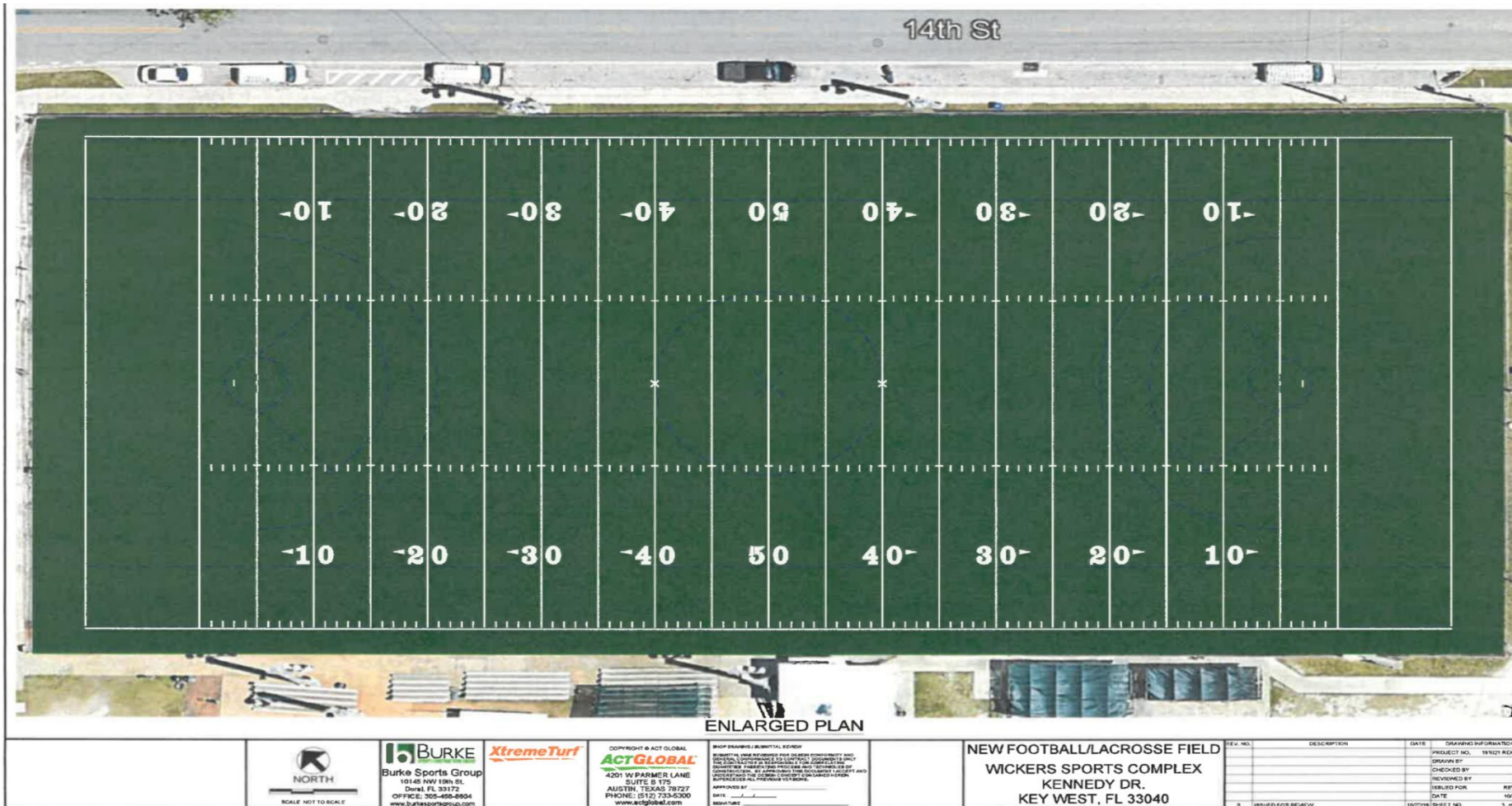
- **Phase 1B- Truman Waterfront-** Expected completion date for building, offices, restrooms and concession stand: October 2020. Multipurpose field construction will begin October 2020, with an expected install time frame of approximately 6-8 weeks.
- **Bayview Park Redesign-** currently in design
- **Bill Butler Park Renovation-** to be completed in 2-3 months
- **George Mira Football Field-** install turf- April 2020
- **Rosa Hernandez Softball field-** install turf July 2020
