(permit application # T17-8388)

An application was received for Final Landscape Plan Approval with Tree Removal. The Tree Commission gave Conceptual Approval for the landscape plan on October 19, 2011. The Planning Board approved the project on October 20, 2011 and it was then subsequently approved by the City Commission.

The approved Development Plan stated, as a condition, that tree removal permits would go through a phased permit review process. Current policy regarding development plans and landscaping with tree removal requires final landscape plan approval for the entire project that also approves the proposed tree removals for the entire project. Monroe County is currently in the process of initiating Phase 1, road realignment, of the master plan. For consistency purposes with current policy, it was decided to have the entire project reviewed for Final Landscape Plan with Tree Removal so that future phases can be reviewed in a timely manner with staff processing the removal permits. This is consistent with the processing that was done for Truman Waterfront Park.

Through this review process, a detailed existing tree map was required for the entire project area. A total of 22 trees are slated to be removed due to their location within the approved construction areas, or because of existing conditions: (7) Green Buttonwood, (6) Gumbo Limbo, (5) Mahogany, (2) Silver Buttonwood, (1) Orange Geiger, and (1) Tropical Almond. A total of (16) Washingtonian Palms and (1) Coconut Palms will also be removed. Trees and palms to be transplanted to other locations on the property include (4) Gumbo Limbo, (2) Mahogany, (1) Silver Buttonwood, and (97) Coconut Palms. The total required replacements for the approved project include 326.5 caliper inches and 17 native palms.

It is noted that the area around the existing Whistling Duck Pond and FAA Tower is considered to be a jurisdictional wetland area. Any work within this area might require review by the State of Florida Department of

Environmental Regulation and the Army Corps of Engineers and is not part of this review process.

The Final Landscape Plan submitted does incorporate all the required tree removal replacements and is over 70% native vegetation.

Recommendation: Recommend approval of the Final Landscape Plan With Tree Removal at 1000 Atlantic Boulevard-Higgs Beach to include the replacement of 326.5 caliper inches of native dicot and/or fruit trees from the approved list, FL#1, and 17-native palms, 4 ft tall, to be planted onsite as per the attached landscape plan. All invasive trees (Brazilian Pepper, Lead Tree, and Mahoe trees) on the entire site will also be required to be removed and eradicated.
