

Adaptation

- **Local Briefing:** Gave “deep dive” presentation for Sustainability Board on 6/13, was covered in Citizen on 6/15. Plan to present to City Commission to bring them up to speed with what the City has been doing for Adaptation. Am helping Legal draft resolution from Commissioner Weekley for 6-month updates.
- **County Meeting:** Meeting with Mayor Johnston and County equivalents to talk Adaptation and Climate Action Plan on 7/8. Will then complete requested agenda for a future projects meeting with City staff.
- **FEMA Flood Maps:** Still awaiting map data. Was supposed to be May or June.
- **NEA Grant:** Meeting with individual commissioners to discuss Master Plan. Commissioner Hoover EcoArt Field Trip report to coincide with adoption meeting. Coordinating field trip with ACM and Commissioner Hoover to Miami Beach to learn about their adaptation efforts.

- **Elevating Houses:** Barbara Powell from DEO is interested in potentially raising homes with remaining mitigation funds. Discussing forming buying group with FIRM.
- **Coastal Adaptation:** Professors and Grad students from the US Naval Academy and Northeastern University arrived 7/1 to deploy monitors for characterization of mangrove effects on wave attenuation. Professors briefed key staff and presented on US1 Radio on 7/2 and 7/3. Working on grad student class project to design a living shoreline project for South Roosevelt or other appropriate spot for winter class.
