I met Charles over 25 years ago when we worked at General Motors in Saginaw, Michigan. He went through a messy divorce and actually had custody of his 4 children. 3 boys and a girl. Through the years we remained very close, and helped each other as friends do. He loved the sun and was an honorable man. The record will show that he was harrassed and jailed numerous times in Saginaw. He shared with me numerous stories of how the Police in Birch Run and Saginaw would stop him and take him to jail. He liked his weed, but that in itself does not make him a criminal. I spoke with him shortly before he left Saginaw. Even set him up with an Attorney named James Fereny (989-859-8788) to go to court with him to address his most current "alleged Offense". He received a good pension from GM, but You and I both know that the "double standard" in our Justice system exists. MONEY TALKS! Perhaps the stress and pressure of dealing with the court in Saginaw was just to much for him. He left me a message on his way down to Florida and told me how sorry he was for not showing up in Court. I paid Fereny \$100.00 for showing up in Court. That's the last I every heard from him. His daughter Erica called me to tell me of his death. On Dec. 17 2013 - Erica called me to say, " Auntie Gail- they killed my daddy". I arrived at my bothers in Ruskinn and called Naja Gihard at Blue Paper. I wacthed the video and cried. I understand your position regarding "jurisdiction" issues, but aftert being incarcerated in the Saginaw, County Jail for 29 days this past Feb. myself, I have numerous questions regarding the abuse of power in our broken system. Sadly the abuse of power transcends every level of our Justice system. As Lawyers practice in front of Judges they elect, I beg you to investigate the Real story. Silence is the voice of complicity. Let those with a voice speak out for the voiceless. There is a conspiracy of fools. Crimes committed by men of "respectability and high social status in the course of their occupation. OUR constitution is butchered. Men who abuse their power because of unacknowledged class biases, outright political deals, poorly drafted laws and incompetent investigators. Charles John is just one of the many that have suffered due to the double standart and consequences of inequality. Perhaps my friends death will not be in vain. PLEASE think about the oath you took?
