A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING CONCH REPUBLIC SEAFOOD COMPANY TO CONDUCT THE FLORIDA POWERBOAT CLUB'S ANNUAL POWERBOAT VILLAGE AT THE 631 GREENE STREET PARKING LOT AND ADJACENT GRAVEL LOT ON WEDNESDAY, NOVEMBER 6, 2024, THROUGH SUNDAY, NOVEMBER 10, 2024 FROM 11:00 A.M. TO 11:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS Conch Republic Seafood Company request permission to hold the Florida Powerboat Club's Annual Powerboat Village on Wednesday, November 6, 2024, through Sunday November 10, 2024 from 11:00 a.m. to 11:00 p.m.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore, commits to refrain from the use or distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic

utensils and "to go" packages for food or products sold on any property leased from the City"

SECTION 3. That Conch Republic Seafood Copmany is hereby granted permission to conduct the Joy Ride on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

SECTION 4. Conch Republic Seafood Company will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 5. That the Florida Powerboat Club's Annual Powerboat Village will be located at the 631 Greene St parking lot and adjacent gravel lot.

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
