**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A.H. OF MONROE COUNTY, INC. TO CONDUCT THE 22<sup>nd</sup> ANNUAL TASTE OF KEY WEST AT MALLORY SQUARE PLAZA & PARKING LOT ON MONDAY, APRIL 24, 2017 FROM 6:00 P.M. TO 9:00 P.M.; (SET UP STARTING AT 8:00 A.M.); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCE FROM 5:00 P.M. TO 10:00 P.M.; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, A.H. of Monroe County, Inc. wishes to conduct their Annual “Taste of Key West” at Mallory Square between the hours of 6:00 p.m. to 9:00 p.m. on Monday, April 24, 2017; and

**WHEREAS**, this event shall take place on the grounds of Mallory Square Plaza during the hours of 6:00 p.m. to 9:00 p.m. on April 24, 2017; and

**WHEREAS**, the sponsors anticipates that amplified music will be played during the event;

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** That A.H. of Monroe County, Inc. is hereby granted permission to conduct their annual “Taste of Key West” on the date and during the hours stated above; **PROVIDED** all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, A.H. of Monroe County, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** That A. H. of Monroe County, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

**SECTION 4.** A.H. of Monroe County, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used that that they will be placed side by side.

**SECTION 5.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
