A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF A PATROL BOAT AND RELATED EQUIPMENT AUTHORIZED FOR THE KEY WEST POLICE DEPARTMENT UNDER 2016 PORT SECURITY GRANT PROGRAM (PSGP) GRANT NO. EMW-2016-PU-00529 IN A TOTAL AMOUNT OF \$362,590.37, PURSUANT TO SECTIONS 2-797(1) & (3), AND 2-844 OF THE CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Police Department staff has recommended the purchase of a patrol boat with radiological equipment under GSA Contract pricing, pursuant to section 2-797(3) of the Code of Ordinances; and

WHEREAS, in Resolution NO. 16-269, the City Commission accepted the award of Grant No. EMW-2016-PU-00529 from the 2016 Port Security Grant Program for federal funding up to \$275,592.00, with a \$91,865.00 City match, for a total project cost not to exceed \$367,457.00; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a SAFE 29 Walk Around Cabin patrol boat and related radiological equipment for the Key West Police Department, under the 2016 PSGP Grant No. EMW-2016-PU-00529 is authorized in a total amount of \$362,590.37, pursuant to sections 2-797(1)&(3) and Section 2-844 of the Code of

Ordinances, as described in the attached Executive Summary from Police Chief Donald J. Lee dated December 13, 2016.

Section 2: These items shall be purchased using PSGP funds and City match, previously approved in Resolution No. 16-269 2016.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
