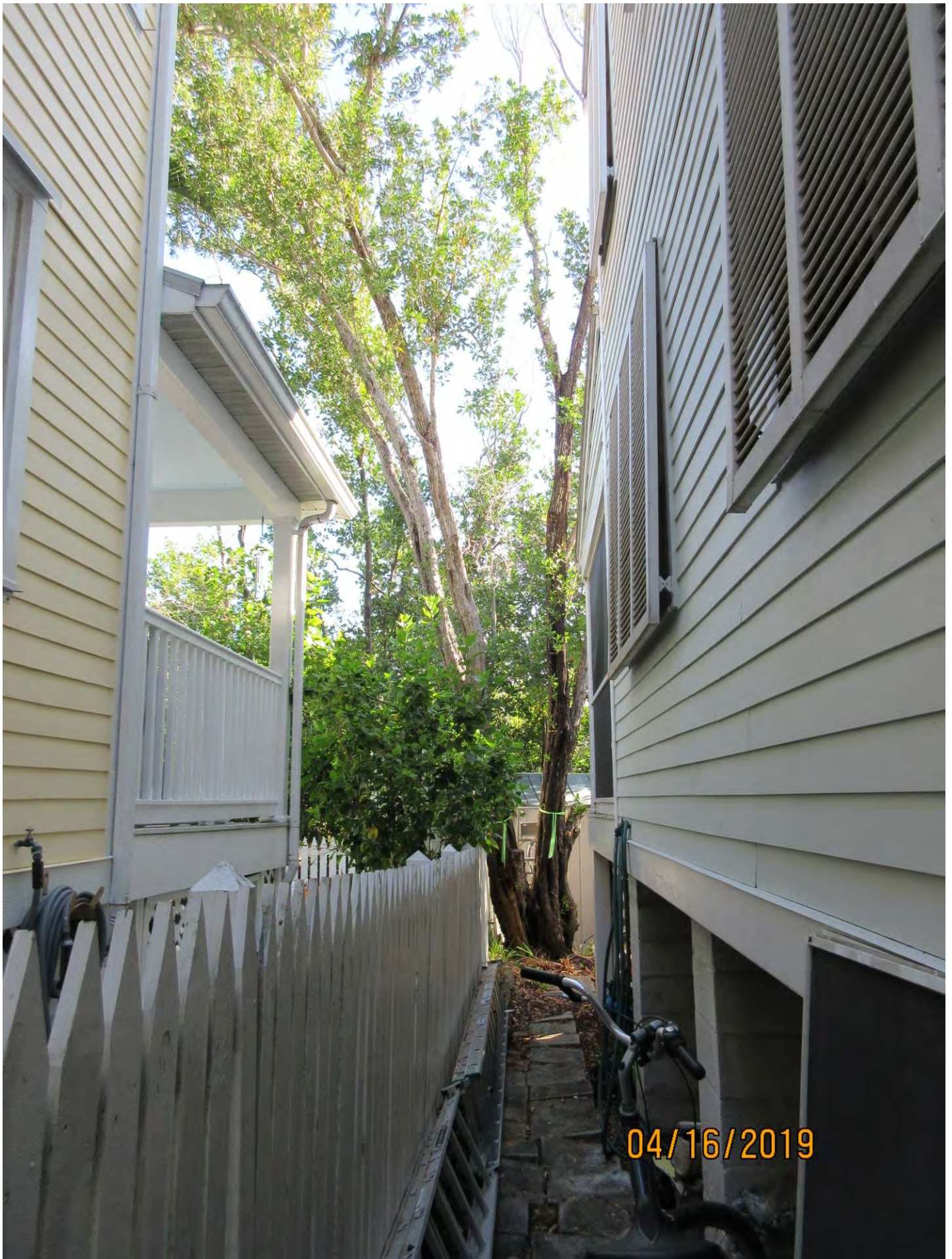

An application was received requesting the removal of **(1) Green Buttonwood tree**. A site inspection was done and documented the following:

Tree Species: Green Buttonwood (Conocarpus erectus)

Diameter: 28.9" (double trunked)

Location: 60% (one trunk leaning against fence where neighbor's AC unit is located, back yard tree)

Species: 100% (on protected tree list)

Condition: 50% (fair to poor, co-dominant trunks, some decay in each trunk and evidence of insect damage)

Total Average Value = 70%

Value x Diameter = 20.2 replacement caliper inches

Alternative: Can one trunk be removed-heavy maintenance trimming instead of full removal of tree with some canopy reduction?
