	On October 6, 2015, I responded to the intersection of Georgia Street and Olivia Street to assist Ofc. Shouldice, Ofc. Kouri, and Ofc Revoredo with a subject that had an active arrest warrant. I arrived and KWPD communications channel two advised the warrant had been confirmed. Ofc. Shouldice and I approached the suspect, previously identified as Adam Korzen. Ofc. Shouldice told Korzen he had a warrant for violation of probation. I told Korzen to place his hands behind his back and he complied. I handcuffed Korzen and walked him to the rear of my marked patrol car. Ofc. Shouldice searched Korzen's person and located a cigarette pack in his front left pocket. Korzen began squirming around and twisting his body from side to side. I told Korzen to relax and to stop twisting around. He

would not comply. Ofc. Shouldice searched the cigarette pack and located a glass pipe with a burnt end and a small piece of burnt steel wool in the end. Once Ofc. Shouldice found the glass pipe, I opened the rear door of my marked patrol car and told Korzen to have a seat in the car. Korzen tensed his body and said, "Don't push me". I told Korzen again to get in the car and again he refused. Korzen continued to tense his body and refused to sit in the rear of my marked patrol car.

I grabbed Korzen on his right shoulder and the left side of his waist. I pulled down on his right shoulder and pushed forward on the left side of his waist to direct him into the rear of my patrol car. I got Korzen into the rear seat, however, his lower legs were still sticking out of the door. I grabbed the back of Korzen's right knee to get him into the rear of my patrol car. Korzen laid down across the rear seat and raised his left leg up, bent his knee, and kicked at me. I avoided Korzen's foot and grabbed onto both of his knees to prevent him from kicking at me again. Korzen then sat up, lowered his head, and lunged his body at me. I rolled my body out of the way and redirected Korzen to the ground. Korzen landed on his back and was lying on his back in the roadway. Korzen then kicked at me with both of his feet. I dodged his kick then immediately and forcefully drove my foot into his right hip to gain control of him and prevent him from kicking at me again. I removed my foot from his hip and I told Korzen to sit up. He refused. I grabbed Korzen on the shoulder and began lifting him up. I gave Korzen several verbal commands to sit up as I was lifting him up. Korzen refused and tensed his body. I left Korzen on the ground and noticed blood on the ground under his head and his right arm. I contacted KWPD communications and requested a supervisor and rescue respond to the scene due to Korzen's actions and my response to his resistance. Korzen said "I'm not getting up". Korzen remained on his back and started yelling "turn the lights on. I know how this shit works". Korzen then said "if you kick me again you fat mother fucker you are going to get it." Korzen yelled "turn the lights on I want this in camera". I pointed to every ones body worn cameras. Korzen then yelled, "Get the camera". Korzen kick at me again. I dodged his kick a second time and drove my foot back into his right hip to gain control of him and prevent him from kicking me. I told Korzen if he did it again he would be Tased. Than I said, "Do you understand. Yes or No! Korzen kept raising his feet up and I gave him loud verbal commands to keep his feet on the ground and to put his feet straight out. Once Korzen complied with my lawful commands I removed my foot from his hip. I asked Korzen if he wanted to sit up and he said no. I explained to Korzen how and why he ended up on the ground. Korzen raised his feet up again and I gave him loud verbal commands to keep his feet on the ground. Korzen did not comply and I drove my foot into his hip again to gain control of him and to prevent him from kicking anyone.

KWFD Rescue arrived to evaluate Korzen's injuries. I told Korzen to sit up and he did. Ofc. Kouri told Korzen not to stand up, or kick at the medics. Korzen said Ok, then said "home boy over here is getting sued". Korzen then laid back down on the street and started kicking his feet. I pulled him back up into the seated position and told him to stop kicking his feet. Korzen continued to push his body backward toward me. I put my left hand on the back of his neck to control his head and my left knee between his shoulder blades to keep in the seated position. Ofc. Kouri went to my patrol car and retrieved a hobble to control his feet and legs. Ofc. Kouri placed the hobble onto Korzen's ankles. Korzen then twisted his body and pulled away from me. I gave Korzen a loud verbal command to stop resisting and directed him into the prone position to re-gain control of him. Once under control Ofc. Kouri secured the hobble on Korzen. I told Korzen to roll on his side and sit up. Korzen sat up and asked "Does this mean resisting?" Sgt. Allen provided me with a spit hood and he placed it on Korzen to prevent him from spitting on anyone. Next I told Korzen to stand up so we could put him on the stretcher. I grabbed Korzen's wrist with my right hand and grabbed under his upper arm with my left hand. I told Korzen to stand straight up. I pulled up on Korzen's upper arm and told him to stand straight up. Korzen's body

went limp and he started screaming. I placed Korzen back on the ground. KWFD rescue brought the stretcher over to Korzen. Ofc. Kouri grabbed Korzen's legs and I grabbed Korzen's upper body. Ofc. Kouri and I picked Korzen up and placed him onto the stretcher. Once on the stretcher Korzen continued to struggle. Ofc. Kouri, Ofc. Hansel, and I were securing the straps on the stretcher and Korzen yelled, "Are you fucking kidding me?" Korzen then started twisting his body and sat up. I pushed his upper body back down on the stretcher and told him to relax himself. Korzen was secured on the stretcher and transported to Lower Keys Medical Center for evaluation and treatment.

Prior to this incident Korzen had several injuries that were in the process of healing. Korzen's toenail on his 5th toe on his left foot had been broken off and was in the process of healing. Additionally Korzen had an abrasion on his right ankle and left elbow that appeared old and were in the process of healing.

As a result of Korzen's resistance he had two visible injuries. The back of Korzen's head had an abrasion on it, his upper right arm had an abrasion near the elbow joint. Ofc. Reveredo photographed Korzen's injuries

Korzen's injuries were evaluated and treated at Lower keys Medical Center. Once Korzen was medically cleared I transported him to MCDC for processing without incident.

I placed the photographs of Korzen's injuries and the glass pipe FTP cocaine into KWPD property and evidence for safekeeping.

	On 10/6/15, at approximately 0930 Hours, Ofc. Revoredo, Ofc. Kouri and I (Ofc. Shouldice) responded to the report of an intoxicated person riding an orange bike in the area of Bayview Park. Upon arrival to the area we were unable to locate the individual. We then were flagged down by another concerned citizen who said there was an intoxicated individual on the 900 block of Georgia Street attempting to ride a bicycle.	
	At the intersection of Olivia and Georgia we observed an individual, later identified as Adam Korzen, attempting to walk his bicycle north bound on the sidewalk on Georgia Street. Korzen was stumbling and bumping into cars, trees and fences. We asked Korzen to have a seat to prevent him from falling down and injuring himself. Korzen appeared to be under the influence of alcohol or drugs. Korzen ad slurred speech, could not stand without falling over and had bloodshot eyes. I asked Korzen if he had been drinking and he said, "Oh my god, I got so fucking drunk at DonÆs Place." Korzen had fresh blood from a number of open lacerations and abrasions on his knees, elbows and head. Ofc. Revoredo attempted to have Korzen contact a responsible person to come pick Korzen up. During this time I ran Korzen over communication channel two.	
	Communications channel two advised me that Korzen had warrant for violation of probation. I then radioed for another unit two assist in the arrest and transport of Korzen. Ofc. Chaustit soon after arrived on scene. I assisted Ofc. Chaustit in handcuffing Korzen and escorting Korzen to Ofc. ChaustitÆs vehicle. I informed Korzen he had a warrant for violation of probation.	
I emptied the contents of KorzenÆs left front pocket onto the trunk of Ofc. ChaustitÆs patrol car. After searching KorzenÆs 305 cigarette pack in KorzenÆs left front pocket, I found a broken glass pipe inside containing a burnt piece of brillo pad. I accidentally pricked my finger on the broken glass. I am unsure if the glass went through the glove and into my finger. A report of injury was done as a preventive measure.

Just as I discovered the glass pipe, Ofc. Chaustit asked Korzen to sit down in the back of the police car. Korzen became combative and would not get into the car. Korzen began yelling at Ofc. Chaustit and pushed towards Ofc. Chaustit in an attempt to get out of the car. Korzen kicked and at one point lowered his head and charged at Ofc. Chaustit. Ofc. Chaustit then redirected Korzen to the ground in a controlled manner.

Korzen was still combative on the ground. Korzen would not listen to Ofc. Chaustit's instructions and continued to scream and kick at Ofc. Chaustit several times. Ofc. Kouri placed a hobble restraint on Korzen to keep him from kicking. KWFD Rescue arrived on scene to transport Korzen to the hospital for evaluation. Ofc. Chaustit and Ofc. Kouri had to assist KWFD in getting Korzen onto the stretcher. Ofc. Revoredo rode in the ambulance with Korzen to Lower Keys Medical Center.

	1	On Tuesday, October 06, 2015 at around 0930 hours, Ofc. Shouldice, Ofc. Revoredo and I (Ofc. Kouri) responded to a report of an intoxicated individual. We were flagged down by a second concerned citizen and located the subject, later identified as Adam Korzen, at the intersection of Olivia Street and Georgia Street.
		Korzen appeared agitated, intoxicated and very nervous. It was determined through F/NCIC that Korzen had an active warrant for violation of probation, which was extraditable. Ofc. M. Chaustit arrived on scene to take over the case. Ofc. M. Chaustit arrested Korzen, pacing him into handcuffs.
		A search of Korzen's person performed by Ofc. Shouldice, at the rear of Ofc. Chaustit's patrol vehicle revealed a glass pipe, with a metal brillo pad stuffed into the end of it. This pipe is commonly used for smoking narcotics, specifically "crack" cocaine.
		At this time, Ofc. Chaustit attempted to place Korzen in the rear of his patrol vehicle. Korzen became combative and began to physically resist. Korzen began to kick at Ofc. Chaustit, push towards him and forced his way out of the rear of the patrol vehicle. Korzen then lowered his head and charged at Ofc. Chaustit. During this attack towards Ofc. Chaustit, Korzen was redirected to the ground in a controlled manner.
		Korzen was still combative while on the ground, and attempted to kick up towards Ofc. Chaustit and other Officers on scene. Korzen was given multiple verbal commands to stop resisting and to stop kicking his feet in the air.
		Ofc. Shouldice said he believed he received a puncture wound to his left thumb from the broken crack pipe that he retrieved from Korzen.
	I placed a hobble restraint on Korzen's legs due to his combative resistance and continuous kicking at Officers.	
	Key West Fire/Rescue arrived on scene to transport Korzen to LKMC for medical evaluation. While placing Korzen onto the stretcher, he continued kicking at me, getting blood on both of my forearms and on my left pant leg.

We were flagged down by a second concerned citizen and located the subject, later identified as Adam Korzen, at the intersection of Olivia Street and Georgia Street.
		Korzen appeared intoxicated and did not want any police interaction. I saw Korzen was unsteady on his feet and had slurred speech. As I spoke with Korzen, I told him to sit down for his safety and asked if he had someone that could pick him up. I asked him about the cuts and abrasions he had on his knees, elbows and head. Korzen said he was really drunk because his girlfriend was leaving him. While I was trying to make contact with a responsible individual to care for Korzen, Ofc Shouldice checked Korzen through Key West communications and found that there was an outstanding warrant for his arrest. The warrant was confirmed through FCIC/NCIC. Ofc. Chaustit arrived on scene and placed Korzen in handcuffs.
		Ofc. Chaustit attempted to place Korzen in the rear of his patrol vehicle. Korzen became combative and began to physically resist. Korzen began to kick at Ofc. Chaustit, push towards him and forced his way out of the rear of the patrol vehicle. Korzen then lowered his head and charged at Ofc. Chaustit. Ofc. Chaustit defeated Korzen's attack and redirected him to the ground in a controlled manner. While on the ground, Korzen attempted to get up and was attempting to defeat any physical efforts to keep him on the ground. I displayed my Taser and recorded the incident on my Taser camera. Korzen was given several loud verbal commands to stop resisting, but he continued to kick out and trying to get out of officers control.
		Ofc. Kouri placed a hobble restraint on Korzen's legs due to his combative resistance and continuous kicking at officers.
		Key West Fire/Rescue arrived on scene to transport Korzen to LKMC for medical evaluation. I rode in the ambulance with Key West Rescue 2 to LKMC where Korzen continued to scream and attempt to fight.
