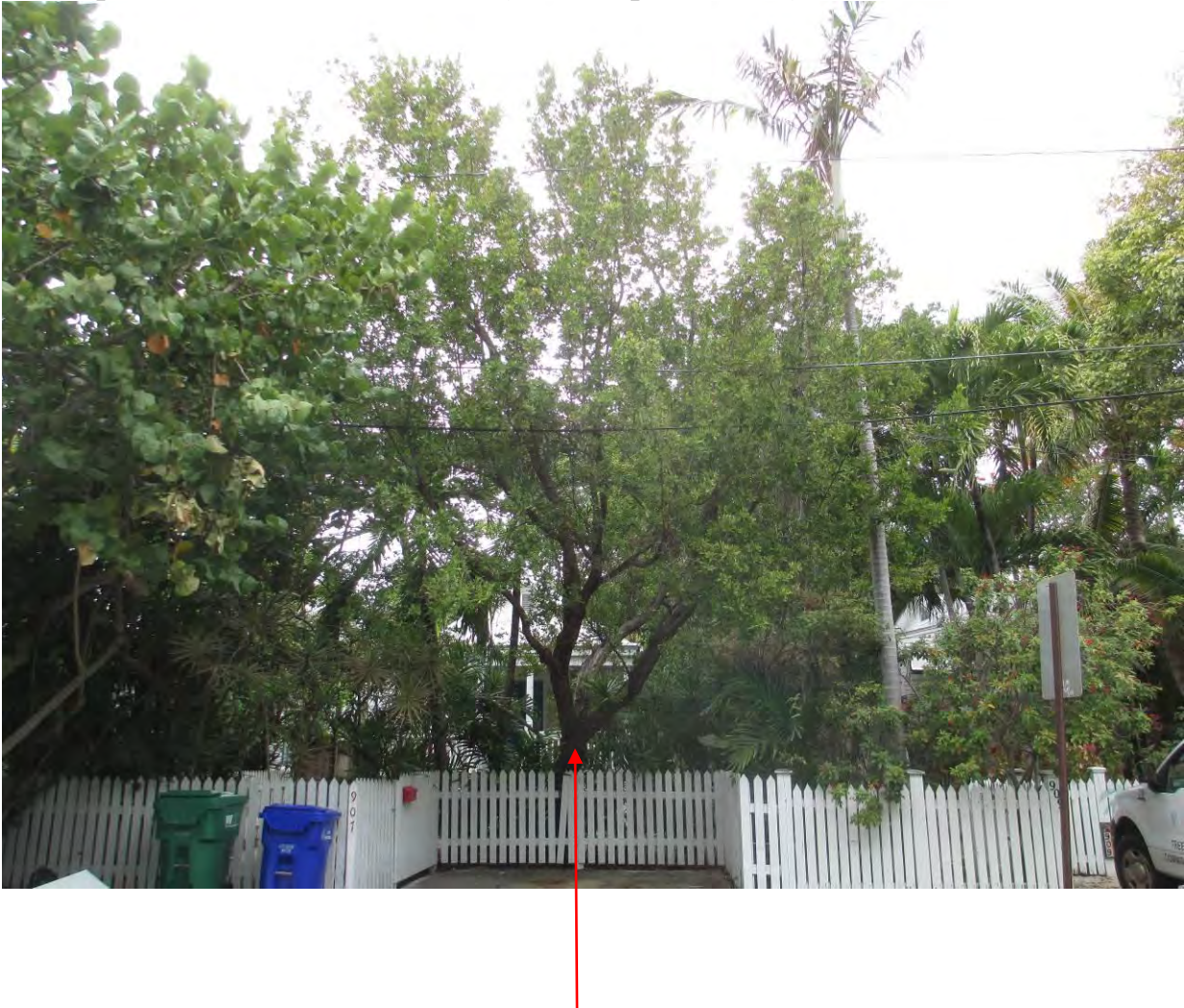

An application was received for the removal of **(1) Green Buttonwood tree**.  
A site inspection was done on February 18, 2015 and documented the following:

Tree Species: Green Buttonwood (*Conocarpus erectus*)

Diameter: 15.6"

Location: 60%

Species: 100% (on protected tree list)

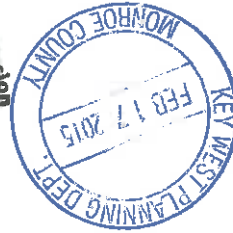
Condition: 30%

Total Average Value = 63%

Value x Diameter = **9.8 replacement caliper inches**

**Recommendations: Recommend approval of the removal of (1) Green Buttonwood tree located at 907 South Street, to be replaced with 9.8 caliper inches of FL#1 native dicot or fruit trees.**
