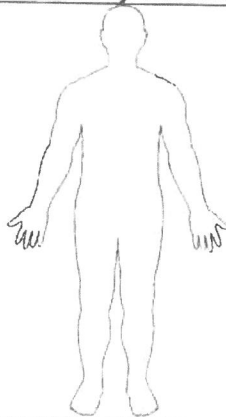

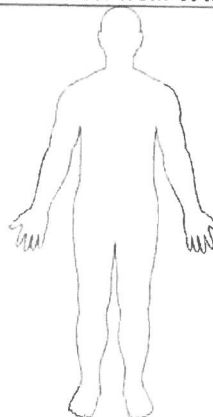

On Thursday, June 21, 2018 at approximately 0600 hours, I, Ofc. Ane, along with the Key West Police Department's Special Response Team and Special Investigations Unit assisted with the execution of a search warrant at 917 Center Street.

Upon arrival at 917 Center Street, The Special Response Team made forced entry into the residence, after no attempts were made by the occupants to allow us inside.

I entered the second bedroom located on the southside of the home. I identified myself as a Key West Police Officer and was wearing my department issued SRT uniform, that has "POLICE" very conspicuously placed on the front. I immediately saw a black male, who know I as Detravis Adams, sitting up right on a bed in the southwest corner of the bedroom. Adams was leaned forward over the side of the bed and was holding a large glass jar that was almost full of a green leafy substance. In my training and experience, I suspected the substance to be marijuana.

I told Adams to drop the jar and get on the floor. Adams ignored my commands, threw the jar under his bed and rolled his body back further onto the bed. I approached him and grabbed his right arm, while telling him to get off of the bed and lay on the floor. Adams immediately tensed his arm and attempted to pull it out of my hands. To keep the situation from escalating any further, I redirected Adams to the floor, using a modified armbar take down, after pulling him towards me.

Once on the ground, I was able to place Adams into handcuffs.

Adams was removed from the house, along with two other subjects that were detained in a separate room.

The residence was secured and turned over to the Special Investigations Unit.

Adams was secured in the rear seat of a patrol, when I saw he had an abrasion to his left shoulder and left knee. Adams advised he did not need medical treatment. I photographed his injuries and later uploaded them to the COBAN server.

All pertinent information was forwarded to Lt. D. Black to document my response to resistance.

I had no further involvement in this investigation.

On Thursday, 06/21/2018, at approximately 0615 hours, the Key West Police Department Special Investigations Unit executed a search warrant at the residence of 917 Center Street with the assistance of the department's Special Response Team. The search warrant was obtained following two buy-walk operations where DETRAVIS T. ADAMS (Arrestee) sold Marijuana to a confidential informant (CI).

The Key West Police Department Special Response Team, located and detained three subjects occupying 917 Center Street during the execution of the warrant. The three subjects, all identified by their Florida Driver Licenses or Identification cards, were identified as DETRAVIS T. ADAMS, KERRY D. GARRETT, and JOSHUA C. CAHILL. The three individuals were placed into handcuffs and escorted out of the residence by the KWPD Special Response Team. My interaction with ADAMS, GARRETT and CAHILL was captured on a handheld recording device. I read Miranda warnings to ADAMS, GARRETT, and CAHILL separately. All three individuals invoked their right to remain silent. Detective M. SIRACUSE recorded an introduction video of 917 prior to a manual search of the interior.

I returned to my unmarked vehicle to retrieve K-9 MANGO for a canine sniff of the residence. I attached my six foot nylon lead to the one and a half inch collar K-9 MANGO was wearing. I escorted K-9 MANGO to the entrance of the residence. I gave K-9 MANGO the command to sniff for the odor of narcotics and we entered the residence. K-9 MANGO conducted a sniff of the living room area, a small dining area, the kitchen and bathroom without any alert to the odor of narcotics. I escorted K-9 MANGO to the room ADAMS had been occupying. I gave K-9 MANGO the command to sniff for the odor of narcotics. K-9 MANGO began sniffing the room. When K-9 MANGO approached the bed in the room, there was an obvious change in K-9 MANGO's normal behavior. K-9 MANGO oriented his attention to the area near a bedside nightstand. K-9 MANGO's respiratory efforts increased and his body posture changed as he scanned the area near the nightstand. K-9 MANGO crawled under the bed in an effort to locate the source. K-9 MANGO came out from under the bed and took one additional deep breath near the bedside nightstand and sat. I provided K-9 MANGO with his toy reward and gave him verbal and physical praise. I escorted K-9 MANGO to the room that was occupied by GARRETT and CAHILL. I gave K-9 MANGO the command to sniff for the odor of narcotics. K-9 MANGO began sniffing the room and oriented his attention to a dresser in the corner of the room. K-9 MANGO's body became ridged and his respiratory efforts increased as he scanned his nose along the dresser. K-9 MANGO sat by the dresser. I provided K-9 MANGO with his toy reward and gave him verbal and physical as I walked him back to my vehicle. K-9 MANGO's canine sniff was recorded on my BWC which I later uploaded onto the KWPD Coban server.

I returned to the residence and assigned Detectives K. MALSHEIMER and M. SIRACUSE to specific rooms in the residence to be searched. I established a specific location inside the residence where I would collect property from those searching. Homeland Security Special Agent J. SEVERSON and Key West Police Officer G. MEDINA and Sergeant B. LARIZ remained with ADAMS, GARRETT and CAHILL at the front of the property.

The Key West Police Department Special Investigations Unit Detectives conducted a manual search of the interior of the residence. Detective K. MALSHEIMER took photos of the evidence as the items were located. I collected the items of evidence as they were found. I field tested all of the items of evidence seized. Detectives located the following from within the residence:

- " 305.3 grams of marijuana contained in three separate glass mason jars, located on the floor of ADAMS's room (estimated street value of \$3,300.00).
- " \$312.00 in US currency, located on a bedside nightstand in ADAM's room.
- " 9.6 grams of MDMA/ecstasy contained in a plastic baggie, located in plain view on the bottom shelf of a bedside nightstand in ADAMS's room (estimated street value of \$950.00).
- " 1 silver digital scale, located on a bedside nightstand in ADAMS's room.
- " 0.5 grams of marijuana from within a tobacco cigarette pack, located on a bedside nightstand in ADAMS's room.
- " 12 small clear plastic baggies containing trace amounts of an off-white powdery substance, located on a bedside nightstand in ADAMS's room.
- " 1 plastic baggie containing 0.2 grams of MDMA/ecstasy, located on a bedside nightstand in ADAMS's room.
- " 5.4 grams of a compressed disk of marijuana, located on top of a dresser in ADAMS's room.
- " A large amount of new clear plastic baggies, commonly used to package illegal narcotics to sell, located on a bedside nightstand in ADAMS's room.
- " 2.7 grams of marijuana contained in two large, used, vacuum sealed bags tucked behind the bed in ADAMS's room (estimated street value of \$40.00).
- " 1 metal grinder containing trace amount of marijuana, located on the floor in ADAMS's room.
- " 8 vaporizer pen tips containing suspected marijuana oil, 1 located on a bedside night stand and 7 located in a backpack in ADAMS's room, these will be sent to the lab to be analyzed. Possible pending charges.

Upon completion of the manual search of the interior, I left a copy of the search warrant and inventory/return sheet on the table inside of the residence. GARRETT and CAHILL were released after finding no narcotics or contraband in the room they had been occupying. I had Officer G. MEDINA transport ADAMS to MCDC. I returned to the Homeland Security building with the evidence collected. I processed the evidence mentioned above and Detective M. SIRACUSE assisted with packaging the evidence. Detective K. MALSHEIMER made a DVD containing videos and photos from the search warrant. I submitted the evidence listed above into the KWPd property section along with the DVD containing all videos and pictures related to the search warrant. I completed and submitted a FDLE lab request form into the KWPd Property section. Detective M. SIRACUSE provided the Monroe County Clerk of Courts with the original search warrant and original inventory and return form (left with Jennifer Diaz).

ADAMS was the only occupant in the room where the items listed above were located during the time of the search warrant entry by the KWPd Special Response Team. No narcotics were found anywhere else in the residence. ADAMS's personal identification was also located his room on top of the nightstand. Of the items located, there was over \$4,000.00 worth of scheduled and controlled substances listed in the Florida State Statutes chapter 893.03. All of the narcotics listed subsequently field tested positive. Such a large quantity of narcotics (marijuana and MDMA/ecstasy), paired with a digital scale and small plastic baggies, is commonly associated with street level sales of narcotics. There was \$312.00 in US currency also located next to the digital scale and narcotics, the denominations of ten dollar bills and twenty dollar bills is consistent narcotics sales. ADAMS's money was placed into the KWPd Property section for safekeeping. ADAMS was well within 1,000 feet of a place for worship (St. Peters Episcopal Church - 800 Center Street) with the intent to sell marijuana. ADAMS was subsequently arrested and transported to MCDC by Officer

G. MEDINA without further incident. Based on the facts and evidence mentioned, I believe probable cause exists that on the 21st of June, 2018, DETRAVIS TYRELL ADAMS did knowingly and intentionally violate the following Florida State Statutes contrary to the peace and dignity of the State of Florida.

I also had 2 arrest warrants for ADAMS reference sale of marijuana within 1000 feet of a place for worship and using a two-way device to facilitate a felony. I provided the Monroe County Detention Center with the original warrants, 18-1637 and 18-3251.
