## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, SPONSORING A MARTIN LUTHER KING BIRTHDAY CELEBRATION AND MARCH ON MONDAY, JANUARY 20, 2025, BETWEEN THE HOURS OF NOON AND 4:00 P.M AT NELSON ENGLISH PARK; AUTHORIZING THE CLOSURE OF CERTAIN STREETS FOR THE MARCH FROM 5:00 P.M. TO 6:00 P.M; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS the City Commission desires to provide a Martin Luther King Jr. Birthday Celebration and March on the date and times herein described.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida, as follows:

**SECTION 1.** That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law:•

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use or distribution of single-use polystyrene/plastic items, including but not limited to single use polystyrene/plastic straws, bags, plastic utensils and "to go" packages for food or products sold on any property leased from the City"

**SECTION 3.** That the City of Key West hereby sponsors a Martin Luther King Birthday Celebration and march on Monday, January 20, 2025, between 12:00 to 4:00 p.m. for the Celebration at Nelson English Park followed by a march starting at 5:00 p.m. and ending at approximately 6:00 p.m.

**SECTION 4.** That all provisions of the Code of Ordinances with respect to a march on the City right-of-way shall be observed.

**SECTION 5.** That the celebration will begin at the Nelson English Park (Martin Luther King Community Center) Thomas and Catherine Streets followed by the march.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
