**A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA) REJECTING ALL BIDS RECEIVED IN RESPONSE TO INVITATION TO BID (ITB) #21-003 CONCH REPUBLIC SEAFOOD COMPANY (CRSC) ROOF/WALL CLADDING - KEY WEST HISTORIC SEAPORT PURSUANT TO SECTION 2-834(3) AND(4) OF THE CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, the responsive bid received in response to ITB 21-003 exceeded cost estimates, and the low bid was non-responsive. Accordingly, staff recommends rejecting the bids received and re-bidding the project; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That the bids received in response to ITB #21-003, for CRSC Roof/Wall Cladding - Key West Historic Seaport are hereby rejected pursuant to city code of ordinances section 2-834(3) and (4).


Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.

## EXECUTIVE SUMMARY

### ACTION STATEMENT

Rejecting bids for ITB #21-003 – CRSC Roof / Wall Cladding – Key West Historic Seaport

### BACKGROUND

Conch Republic Seafood Company is an all metal structure in a highly corrosive environment. The roof on the structure is nearing the end of its useful life and the walkway overhang is experiencing heavy corrosion to both primary and secondary steel framing elements and need replacement. The wall cladding and wall girt are also experiencing heavy corrosion and are in need of repair/ replacement.

### PURPOSE & JUSTIFICATION

ITB #21-003 was advertised April 2021 with 2 bids received on May 5, 2021 as follows:

D.L. Porter Constructors, Inc.	\$711,406.00
Marino Construction Group	\$894,399.60

Staff has reviewed the breakdown of the proposals received and determined the line item pricing to be unbalanced and slightly high for the scope of work. Also, the low bidder DL Porter did not provide the require unit prices for five bid items, only providing lump sum amounts making them a non-responsive bidder. Per the solicitation, the City may reject bids if a bidder is non-responsive and if is in the best interest of the City.

Seaport staff will re-advertise this project immediately.
