An application was received for the removal of **(1) Gumbo Limbo tree and (3) Unidentified, non-native fruiting trees**. A site inspection was done on February 23, 2015 and documented the following:

1. Tree Species: Gumbo Limbo (*Bursea simarouba*)

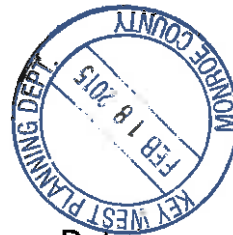

Regarding removal of the Gumbo Limbo tree-the alternative of heavy maintenance trimming to remove the portion of the trunk that is decayed, would create a lopsided tree with the weight toward the direction of the patio and house. The tree already is having some weight issues as indicated by the larger surface roots on the one side of the tree (opposite of the house) near the solution hole.

Recommendations: Recommend approval of the removal of (1) Gumbo Limbo tree and (3) Unidentified, Non-Native Fruiting trees located at 618 Free School Alley, to be replaced with 38.2 caliper inches of FL#1 native dicot or fruit trees.

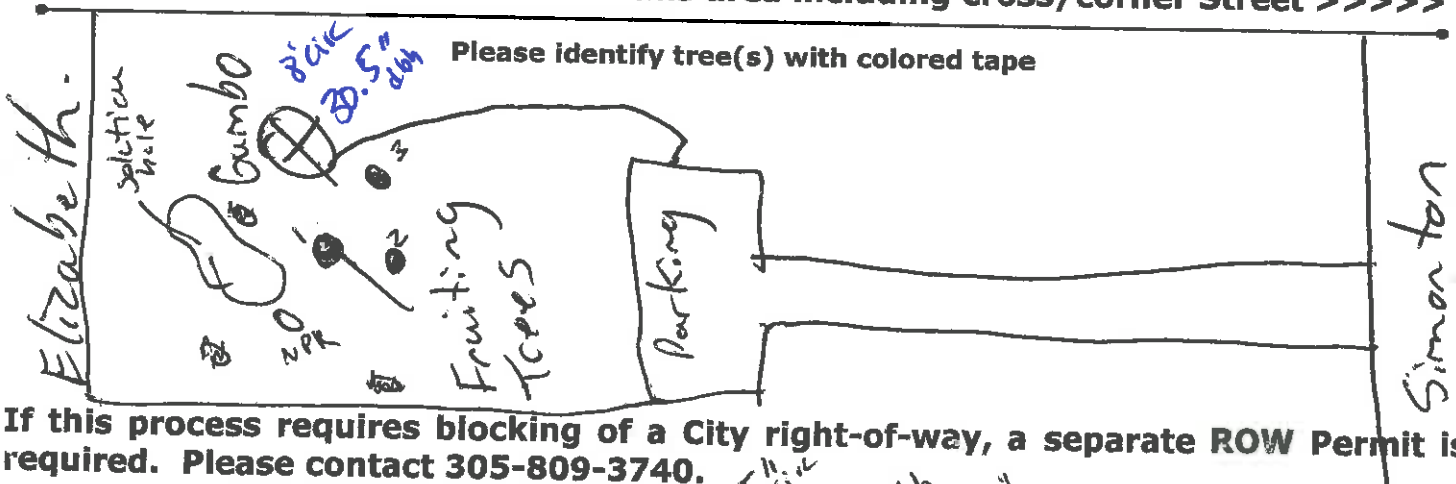
