An application was received requesting the removal of **(1) Mahogany tree**. A site inspection was done on February 17, 2016 and documented the following:

Tree Species: Mahogany (Swietenia mahagoni)









Diameter: 5"

Location: 50% (tree is close to property line, will become an issue as it grows, wrong tree wrong place)

Species: 100% (on protected tree list)

Condition: 70% (good)

Total Average Value = 73%

Value x Diameter = 3.6 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Mahogany tree at 1100 White Street to be replaced with 3.6 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

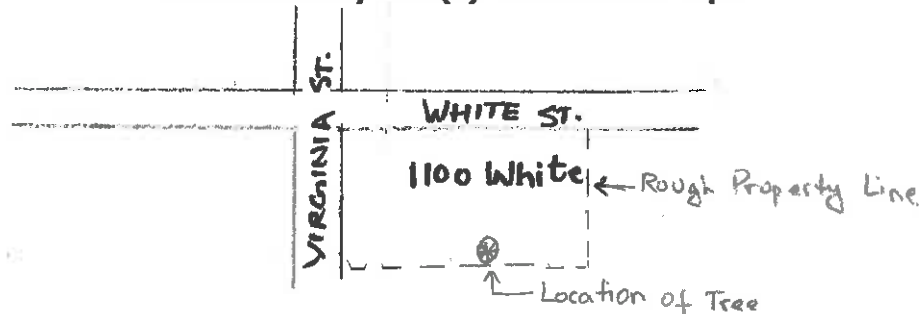
