COMMENTS REGARDING LANDSCAPE PLAN: The development plans accurately identify the locations of the existing trees and trees to remain on site. The City of Key West will be responsible for transplanting the identified sabal palms along United Street. The contractor is responsible for transplanting the identified coconut trees.

The relocation of the memorial butterfly garden has been coordinated with the Butler Family. The memorial stone will be moved to a protected storage location during construction activities. Once construction is completed, the stone will be installed in the new butterfly garden to be recreated at the rear of the property along Grinnell and United Street. The public will have an opportunity to harvest plants and cuttings from the existing memorial garden on White Street on Saturday, April 12 from 8 a.m. to noon.

The Major Development Plan, Conditional Use and Landscape Waivers have been approved by the Planning Board. The final decision will come from the City Commission

at the June 3, 2014 City Commission meeting. The request is for waivers from all required landscape/buffer requirements, except minimum 20% landscaping requirement (sec 108-412) and non vehicular use areas (sec 108-416).

The landscape plan includes the planting of over 260 caliper inches of dicot tree replacements and 67 native palm trees which exceeds the proposed Tree Permit requirements.

It is recommended that root barriers be used in planter areas along sidewalks and the parking lot.

RECOMMEND: Approval of Final Landscape Plan and Tree Removals.

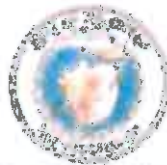
