An application was received requesting the removal of **(1) Gumbo Limbo tree**. A site inspection was done on June 7, 2016 and documented the following:

Tree Species: Gumbo Limbo (*Bursera simaruba*)















Diameter: 16.5"

Location: 60% (close to property line, most of the canopy of the tree is over the road and into the utility line, future impacts to utility pole and transformer area)

Species: 100% (on protected tree list)

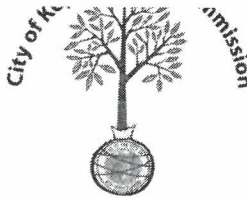
Condition: 40% (healthy tree, poor structure, heavily weighted toward street-storm risk)

Total Average Value = 66%

Value x Diameter = 10.8 replacement caliper inches

Recommendation: Recommend approval of the removal of one (1) Gumbo Limbo tree at 3620 Sunrise Drive to be replaced with 10.8 caliper inches of dicot or fruit trees from approved list, FL#1, to be planted on site.

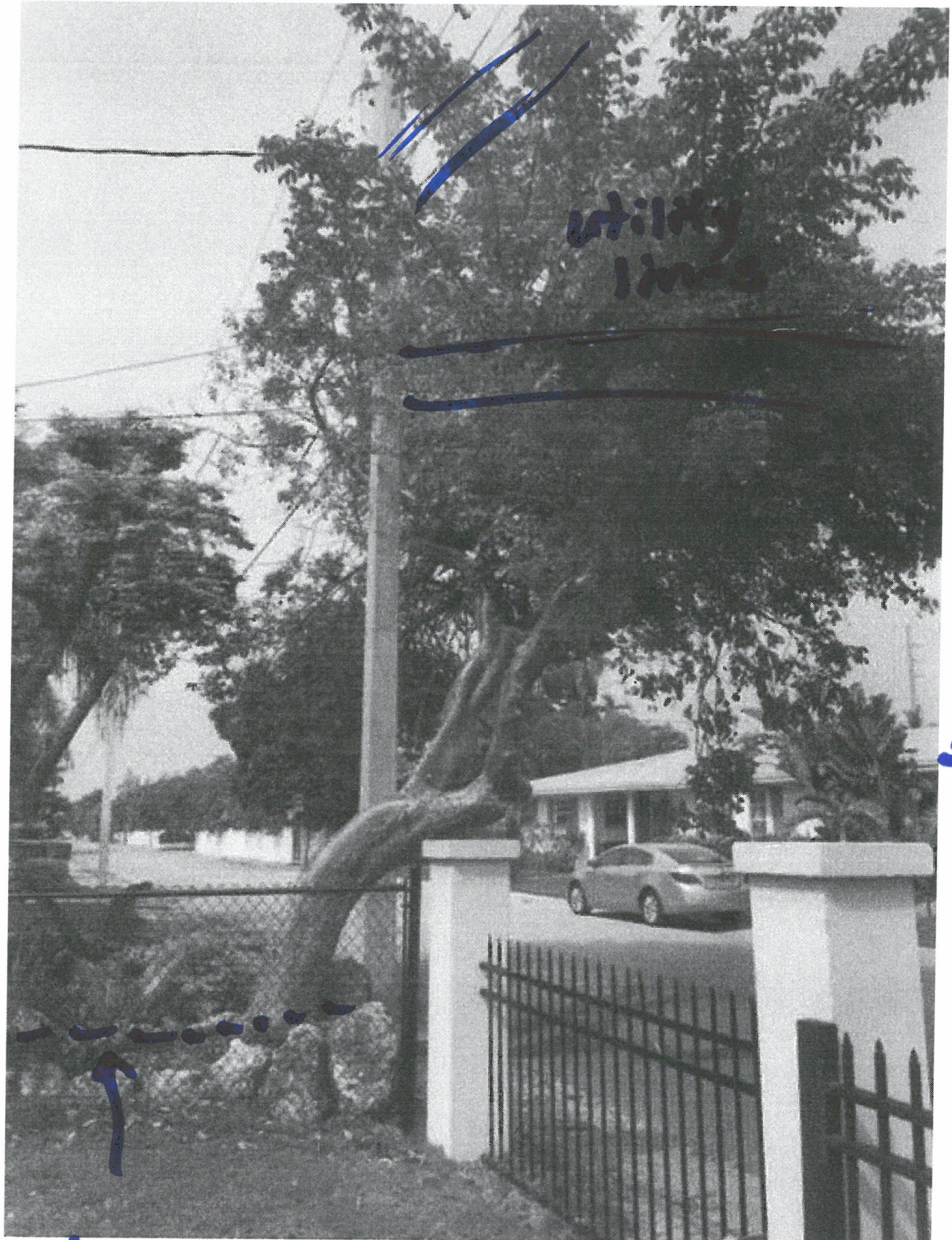
