


## Diameter: 24.8"

Location: 70% (on city right of way close to property line and driveway area)

Species: 100% (on protected tree list)

Condition: 30% (overall condition is poor, section of tree broke off main trunk and tore into the heartwood of the main trunk, remaining canopy is lopsided. Tree is at moderate to high risk of failure into the road area) Total Average Value = 66%

Value x Diameter = 16.3 replacement caliper inches




