Description of Work:

Partial demolition of non-historic rear roof and accessory structures.

Site Facts:

The principal building in the site is listed as a contributing resource to the district. The one-story frame vernacular house was built circa 1890. Originally the house had only a front porch. According to the Sanborn maps between 1898 and 1912 a side porch was created at the south elevation, making a "L" shape porch. The rear configuration of the house was change after 1962, where an addition with a shed roof was attached to the house and build over an old cistern. A structure dedicated for a car was built on or after 1926 on the south east portion of the lot. The main house is elevated in footers approximately 2-11" from grade while the detached accessory structure is built at grade. The accessory structure located at the south east side of the lot is sided with corrugated metal and is dilapidated.

Ordinance Cited on Review:

• Section 102-217 (2), demolition for non-contributing or non-historic structures of the Land Development Regulations.

Staff Analysis:

The Certificate of Appropriateness under review is for the partial demolition of a non-historic shed roof attached at the rear east side of the principal building. The plan also includes the removal of a dilapidated one-story non-historic shed and a small non historic shed located on the north east side of the parcel. The applicant has submitted plans for new accessory structures and replacement of rear roof. The historic architectural review commission shall not issue a certificate of appropriateness that would result in:

- (1) Removing buildings or structures that are important in defining the overall historic character of a district or neighborhood so that the character is diminished;
 - It is staff's opinion that current non-historic structures and rear shed roof do not define the historic character of the site or neighboring area. Their location and setbacks from the street do not covey urban patterns found historically on the site and throughout the surrounding historic urban fabric.
- (2) Removing historic buildings or structures and thus destroying the historic relationship between buildings or structures and open space;
 - The buildings and rear roof in question are not historic and their demolition will not destroy any urban relationship acquired through time.
- (3) Removing an historic building or structure in a complex; or removing a building facade; or removing a significant later addition that is important in defining the historic character of a site or the surrounding district or neighborhood.
 - It is staff's opinion that the structures in question do not define the historic character of the site.
- (4) Removing buildings or structures that would otherwise qualify as contributing, as set forth in <u>section 102-62(3)</u>.
 - The structures and rear roof in question are not historic or contributing and it is staff's opinion that they will not qualify as contributing resource to the historic district in a near future.

Staff finds that the request demolition for the non-historic rear shed roof and accessory structures can be considered by the Commissioners as it conforms with current ordinances for demolition under the LDR's. If approved, this will be the only required reading.


1899 Sanborn Map











EXISTING FIRST FLOOR PLAN




