A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING ISSUANCE OF TASK ORDER NO. 10 TO BLACK & VEATCH CORPORATION FOR ENGINEERING DESIGN AND BID-PHASE SERVICES FOR REPLACEMENT OF THE EXISTING BELT FILTER PRESS DEWATERING SYSTEM AT THE RICHARD A HEYMAN ENVIRONMENTAL PROTECTION FACILITY IN AN AMOUNT NOT TO EXCEED \$261,257.00; AUTHORIZING NECESSARY ANY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-207, the City Commission approved a three-year contract for General Engineering Services to Black & Veatch Corporation and in Resolution No. 20-142 the contract was extended two years; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

<u>Section 1</u>: That Task Order No. 10 to Black & Veatch Corporation for Engineering Design and Bid-Phase Services for Replacement of the existing belt filter press dewatering system at the Richard A. Heyman Environmental Facility, in an amount not to exceed \$261,257.00, is hereby approved.

Section 2: That adequate funds for Task Order No. 10 are budgeted in account Sewer/Wastewater Treatment Plant/CIP 401-3504-535-6500, Project #SE35042006, and any necessary budget transfers or adjustments are hereby approved. <u>Section 3</u>: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
