A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE PURCHASE OF FLEXI-PAVE MATERIAL FROM K.B. INDUSTRIES, INC. IN AN AMOUNT NOT TO EXCEED \$226,739.60 ON A SOLE SOURCE BASIS PURSUANT TO SECTION 2-797(1) FOR BRAND NAME ITEMS IN ACCORDANCE WITH 2-844 OF THE CODE OF ORDINANCES, FOR WATERFRONT PARK; AUTHORIZING NECESSARY TRANSFERS AND ADJUSTMENTS: AUTHORIZING THE CITY MANAGER OR DESIGNEE EXECUTE NECESSARY DOCUMENTS CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, Key West Code of Ordinances section 2-844(a) further provides "Since use of a brand name specification is restrictive of product competition, it may be used only when the purchasing agent makes a written determination that only the identified brand name item will satisfy the city's needs."

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of Flexi-Pave material from K. B. Industries, Inc. in an amount not to exceed \$226,739.60 is hereby approved for renovation of Truman Waterfront Park Playground, pursuant to Section 2-797(1), in accordance with Section 2-844, of the code of ordinances.

Section 2: That funding in the amount of \$200,000.00 is budgeted in Account 101-7201-572-63, and a transfer from Infrastructure Surtax/Reserves in the amount of \$26,739.60 is hereby authorized.

Section 3: That the City Manager or Designee is authorized to execute any necessary documents for this procurement, upon consent of the City Attorney.
