MEMORANDUM

RE: Tree Commission Settlement Agreement and Tree Permit Referral to Special Magistrate-1501 George Street (file number TC2020-0003)

From: Karen DeMaria, Urban Forestry Manager, City of Key West

During an inspection of 1501 George Street for a building permit-pool construction it was documented that a key lime tree existed in the proposed work area and another tree had recently been cut down. On February 18, 2016, an application was submitted to the Tree Commission for the transplanting of a Key Lime tree, 4.1 inch diameter, at 1501 George Street for the construction of a pool (T16-7833). On February 25, 2016 a permit was issued to transplant the Key Lime tree.

On March 8, 2016, a Settlement Agreement was approved by the Tree Commission with Michael Donoghue, property owner, regarding the unauthorized removal of a Mango tree at 1501 George Street (TC2020-0003). The agreement required that Mr. Donoghue replant 4.7 caliper inches of FL #1 native dicot or fruit trees within 6 months of the date of this signed agreement and submit an after the fact removal permit for the tree (T16-7854).

On April 4, 2016, information was received that the Key Lime tree was dead therefore, 4.1 inches of approved trees must be planted to close this file. The transplant permit states: "Transplanting work shall follow ANSI A-300 Standards and if the tree dies within the one (1) year establishment period, it shall be replaced with a new tree of equal value." Standard procedures are that equal value means replacing with a tree of equal diameter and species. Therefore, in order to close out the two permits and the enforcement case a total of 8.8 caliper inches of approved trees needs to be planted on the property.

On January 6, 2017, a job completion form was submitted. By email dated February 9, 2017, Mr. Donoghue was notified that the files could not be closed due to lack of access and by looking over the fence it was documented that most of the vegetation planted were ornamental plant species and not trees from the approved tree list. An additional inspection was attempted on June 12, 2017. Photos were taken from over the fence due to lack of access.

An actual site inspection was conducted on July 19, 2017 which documented that a lemon/key lime tree, approximately 1 inch diameter, and a Carambola/Starfruit tree, approximately 1 inch diameter, was planted on the property (trees #1 and #2). No other planted vegetation on the property was noted or observed as being appropriate for closure of the tree files.

In August 2018, the property owner via email indicated that Hurricane Irma (September 2017) destroyed trees on the property and requested closure of the permit. A site inspection was attempted of the property to document the vegetation and documentation was requested from the property owner regarding any additional trees planted after the July 2017 inspection. The inspection documented that no changes occurred to the planted vegetation from previous inspections except growth. To date no documentation has been received from the property owner. Several standard reminder letters have been sent to the property owner requesting compliance to the issued permits but no response has been received therefore, no additional inspections have been done the property.

Therefore, in accordance with Sec 110-292, this file is being forwarded to the code enforcement special master for further hearing and penalty.

Needed for File Closures:

- 1. Inspection of property to document condition of two planted fruit trees.
- Additional planting of trees-if starfruit and lemon/lime tree still healthy then a total credit of approximately 2 inches will be given, dependent on existing size of trees. Therefore, 8.8" 2" = approximately 6.8" of additional plantings required or a fee paid to the City of Key West Tree Fund (\$200 per inch).



TREE COMMISSION OF THE CITY OF KEY WEST, FLORIDA COMPLIANCE SETTLEMENT AGREEMENT

This ("Agreement"), is made and entered into this 12th day of April 2016, by and between Michael Donoghue, having an address of 1501 George Street, Key West, Florida 33040, ("Property Owner"), and the City of Key West, a municipal corporation, having an address of 3140 Flagler Avenue, P.O. Box 1409, Key West, Florida 33041-1409, by and through the Tree Commission of the City of Key West, Florida ("Tree Commission").

WITNESSETH

Whereas, Chapter 110 of the Code of Ordinances for the City of Key West provides for hearings of violations, notice, procedure and compliance settlement with regard to the damage or destruction of certain protected trees; and

Whereas, in accordance with Chapter 110 of the Code of Ordinances for the City of Key West, the Tree Commission conducted a hearing and rendered a decision with respect to a certain violation of Chapter 110.

NOW, THEREFORE, in consideration of the mutual covenants contained herein and for other good and valuable consideration, the parties agree as follows:

Acceptance of Responsibility for Damage or Destruction:
 Violator accepts full and complete responsibility for the damage or destruction of protected and regulated trees on real property located at 1501 George Street, in the City of Key West, Florida, in violation of Chapter 110 of the Code of Ordinances for the City of Key West, as found in the findings made and decision issued by the Tree Commission at its hearing held on March 8, 2016.

Remedy:

Pursuant to Section 110-291 of the Code of Ordinance for the City of Key West, the Tree Commission has ordered, and Violator agrees to, the following remedy:

- a. The property owner (Michael Donoghue) shall submit a tree permit application for the after-the-fact removal of one (1) Mango tree and replace with 4.7 caliper inches, FL#1, native dicot, or fruit trees from the approved list, to be planted on site.
- b. Replacement trees shall be planted according to 'Best Management Practices' within 6 months of the date of this signed document.
- c. Consistent with permitting requirements, the replacement trees shall remain alive for a minimum of 1 year or replace with like.
- The City of Key West, Urban Forestry Program Manager shall be contacted for inspection of required tree installation.

The remedy as indicated above is based upon the value of the damaged or destroyed tree, as found by the Tree Commission.

Penalty for Non-Performance:

Failure of Violator to comply with the remedy indicated in Paragraph 2 above shall result in the institution of any and all permitted administrative and legal actions.

4. Sale of Property:

In the event the subject property is sold prior to the completion of compliance with this Agreement, the new owner shall be subject to the terms and conditions of this Agreement. It shall be the duty of the selling property within ten days of the effective date of the sales contract to provide the buyer with a copy of this Agreement. The landscape division shall issue a letter to the property owner when compliance is achieved.



The settlement agreement and permits require the replacement of 4.7 caliper inches (T16-7854) and 4.1 caliper inches (T16-7833) for the key lime tree that died when transplanted (total 8.8 caliper inches-caliper is a width measurement of the trunk taken 6 inches above the ground). A list of the approved replacements for these trees was attached to the permit and it does not include palms or vines. All of the palms I could see are areca palms and are not approved palms for replacements. I could not clearly identify the two trees noted on the job completion form as Tree 1 and Tree 2. The other various misc plants are ornamentals that are not on the approved replacement tree list. Therefore, I can not close out the file at this time.

Attached is an updated replacement tree list for your review and use. The City recently added some additional trees to the list. Please contact me when you are ready for and inspection.


