An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

• Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)

- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)

Please note that the EIN on the W-9 is that of our owner parent company, Eurofins Environment Testing America Holdings, Inc. On October 5th, 2021, Eurofins Environment Testing Southeast (Southeast) became a single member LLC and a disregarded entity for Federal tax purposes. As a result of this structural change, the IRS requires the owner's name on Line 1, the disregarded entity's name on Line 2 (Southeast) and the owner's EIN included in Part I. The attached W9 is reflective of this change. For payment purposes please use Southeast's tax ID #87-2895395 in your vendor system, so that payment is processed correctly.

The EIN of 84-4101298 on the attached W-9 is our parent company's EIN.

Please be sure to continue paying the same Accounts Payable address for your Southeast analytical work. The AP address and lockbox information has not changed.
