**AN ORDINANCE OF THE CITY OF KEY WEST,  
FLORIDA, PURSUANT TO SECTION 8.01 OF THE  
KEY WEST CHARTER PROPOSING THAT SECTION  
3.02 OF THE KEY WEST CHARTER BE AMENDED  
TO ADD A ONE YEAR RESIDENCY REQUIREMENT  
TO QUALIFY AS A CANDIDATE FOR MAYOR OR  
CITY COMMISSIONER; PROVIDING FOR  
SEVERABILITY; PROVIDING FOR REPEAL OF  
INCONSISTENT PROVISIONS; PROVIDING FOR  
AN EFFECTIVE DATE**

WHEREAS, Florida Statutes Section 166.031 and Key West Charter Section 8.01 provide the City Commission with the authority to propose by ordinance a Charter amendment, and;

WHEREAS, the City shall follow Florida Statutes Section 100.342 concerning notice of a referendum and Florida Statutes Section 101.161 concerning preparation of the referendum ballot, and;

WHEREAS, section 3.02 of the City Charter for the City of Key West is a provision setting forth the qualifications for a candidate to be Mayor or a City Commissioner, and;

WHEREAS, The City Commission for the City of Key West finds that having a one year residency requirement to be Mayor or a City Commissioner is in the best interest of the citizens of the City of Key West to ensure that qualified candidates are invested in the City and have established

sufficient community ties to the City to make for better governance, and;

WHEREAS, the City Commission desires that the proposed referendum appear on the Primary Election ballot of August 23, 2022.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEY WEST, FLORIDA:**

Section 1: That an amendment to Key West Charter section 3.02 shall hereby be presented as a referendum to the voters of Key West. The question appearing on the ballot shall have the following title: "Referendum - Amendment to Sec. 3.02 of the city charter to require a one-year continuous residency requirement to be eligible for the office of Mayor or City Commissioner." The question appearing on the ballot shall be worded as follows:

"Should city charter Sec. 3.02 be amended  
to require candidates for Mayor or City  
Commissioner have a one-year continuous  
residency in the City of Key West?

Section 2: In the event of the passage of the proposed Charter amendment set forth in section 1, above, Section 3.02 of the Key West Charter shall be amended as follows:

Sec. 3.02 Qualifications For Mayor and Commissioners

Any elector of the city shall be eligible to hold the office of mayor. Any candidate for mayor or City Commissioner shall reside in the City of Key West at the time of qualification continuously for at least one year. Any elector of the city who, as of the date of qualification, resides in the district which he or she is seeking to represent ~~continuously for at least one year~~ shall be eligible to hold the office of city commissioner. Any person elected to represent a district shall maintain residency in that district for the term of office. The city commission shall be the judge of the election and qualifications of its members and of the grounds for forfeiture of their office. A member charged with conduct constituting grounds for forfeiture of this office shall be

entitled to a public hearing on demand and notice of such hearing shall be published in one (1) or more newspapers of general circulation in the city at least one (1) week in advance of the hearing.

Section 3: The City Clerk is hereby authorized and instructed to take all necessary and proper action to place the referendum question set forth in Section 1, above, on the Primary Election ballot of August 23, 2022, and to provide notice of the referendum election as provided by law.

Section 4: If any section, provision, clause, phrase, or application of this Ordinance is held invalid or unconstitutional for any reason by any court of competent jurisdiction, the remaining provisions of this Ordinance shall be deemed severable therefrom and shall be construed as reasonable and necessary to achieve the lawful purposes of this Ordinance.

Section 5: All Ordinances or parts of Ordinances of said City in conflict with the provisions of this Ordinance are hereby superseded to the extent of such conflict.

Section 6: This Ordinance shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
