-- Gabrielle Grace Simmons Arrest Narrative:

On Sunday, 02/20/2022 at approximately 2233 hours; Ofc. Brable, Ofc. Litton, Ofc. Ham and I (Ofc. Howell) were dispatched to 202 Duval Street (Rick's Bar) regarding a possible physical disturbance.

I arrived on scene first and I was flagged down by several Rick's Bar managers regarding an unknown white female subject and an unknown white male subject yelling and causing a disruption to patrons, striking one another, and pushing one another to the ground several times. I encountered Gabrielle G. Simmons (DOB: 01/08/2003, Arrestee) and John P. Simmons (DOB: 08/24/2001) who attempting to push through Rick's Bar security as well as Rick's Bar managers to return to the bar. I spoke with Rick's Bar manager Jason D. Walck (DOB: 06/16/1980, Witness) who stated that G. Simmons and J. Simmons were removed from Rick's Bar several times throughout the night. I stepped in front of G. Simmons as she attempted to reenter the bar and requested her identification. G. Simmons refused to provide her identification and attempted to shove me several times. I gave G. Simmons several loud and concise verbal commands to step back onto the sidewalk, off the business's property. G. Simmons again refused to comply and attempted to swing her open hand toward my face and head. I grabbed G. Simmons by the right wrist and attempted to place her in protective custody. G. Simmons suddenly and swiftly attempted to pull her arm away and attempted to strike me with her left hand and left elbow. G. Simmons attempted to pull away from me continuously. Given these circumstances and G. Simmons' level of resistance rising, I performed a leg sweep technique and took G. Simmons to the ground in a controlled manner. I attempted to grab G. Simmons' shirt however, due to G. Simmons struggling with me, I could only grab the back of her left arm as I performed the technique. G. Simmons continued to physically resist. Off-duty Florida Highway Patrol Trooper B. Williamson (3859) assisted in restraining G. Simmons until Ofc. Brable and Ofc. Ham arrived as my back up. Trooper B. Williamson and I placed Simmons in handcuffs.

G. Simmons received some minor lacerations to her top and bottom lips from the takedown, as a result of her resistance. G. Simmons had a small amount of blood around her mouth. G. Simmons initially refused medical attention from Key West Fire/Rescue on scene several times.

I searched G. Simmons subsequent to arrest. I walked Simmons to my patrol vehicle and placed her in the passenger side, rear seat of my patrol vehicle. As I began to transport G. Simmons to Monroe County Detention Center, she decided that she actually wanted medical attention. I transported G. Simmons to Lower Keys Medical Center.

G. Simmons refused to be seen by Dr. Guerdan. G. Simmons was given a medical clearance and I transported her to Monroe County Detention Center.

G. Simmons continuously screamed and yelled obscenities throughout the transport to Lower Keys Medical Center as well as Monroe Country Detention Center.

Based on the facts and evidence, I believe there is probable cause that on 02/20/2022, Gabrielle G. Simmons did knowingly and intentionally violate F.S.S. 843.01 Resisting with Violence, by purposefully and intentionally attempting to shove me several times, attempting to continuously struggle away from me and attempting to strike me, while I was engaged in my legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 02/20/2022, Gabrielle G. Simmons did knowingly and intentionally violate F.S.S. 509.143 Disorderly Conduct on The Premises of an Establishment; by purposely disturbing the peace, corrupting the public morals and attempting to disrupt patrons of the business and in

Based on the facts and evidence, I believe there is probable cause that on 02/20/2022, Gabrielle G. Simmons did knowingly and intentionally F.S.S. 810.09-1A1 Trespass on Property Other Than Structure or Conveyance, by actually and intentionally remaining on the premises and refusing to leave the property, after being warned several times.

Ofc. Ham retrieved Rick's Bar security footage of G. Simmons and J. Simmons fighting throughout the bar and on the sidewalk. I uploaded copies to Evidence.com.

G. Simmons appeared to be under the influence of alcohol. G. Simmons' speech was slurred, and her eyes were glassy and bloodshot. G. Simmons' breath had the odor of alcoholic intoxicants.

My BWC was activated for the encounter, takedown, arrest, and subsequent search of G. Simmons. I uploaded the videos to Evidence.com.

Simmons as she attempted to reenter the bar, J. Simmons ran by me back into the bar. J. Simmons was again removed by Rick's Bar security and managers. As off-duty Florida Highway Patrol Trooper B. Williamson (3859) assisted in restraining G. Simmons and placing her in handcuffs, Ofc. Brable and I placed J. Simmons in handcuffs.

Ofc. Brable searched J. Simmons subsequent to arrest. Ofc. Brable and Ofc. Ham walked Simmons to Ofc. Brable's patrol vehicle and placed him in the passenger side, rear seat of Ofc. Brable's patrol vehicle.

Ofc. Brable transported J. Simmons to Monroe County Detention Center, without incident.

Based on the facts and evidence, I believe there is probable cause that on 02/20/2022, John P. Simmons did knowingly and intentionally violate F.S.S. 509.143 Disorderly Conduct on The Premises of An Establishment; by purposely disturbing the peace, corrupting the public morals and attempting to disrupt patrons of the business and in the surrounding area.

Based on the facts and evidence, I believe there is probable cause that on 02/20/2022, John P. Simmons did
