Dear Ms. Herron,

On behalf of the City Commission of the City of Key West, please find enclosed a request to the Florida Division of Economic Opportunity for funds allocated through the Community Develop Block Grant – Disaster Recovery (CDBG-DR) program, or Rebuild Florida Infrastructure Repair Program – Competitive Cycle 2, to support the City's Force Main Relocation Project. This project will resolve a delicate vulnerability of our wastewater conveyance system.

Currently, all wastewater within City limits is conveyed across an above-water bridge onto an adjacent island (Key), managed and protected by the US Naval Station where a treatment plant exists and treats the City's wastewater. The bridge and conveyance above water is vulnerable and was struck by adrift vessels and debris during Hurricane Irma. Tidal wave action, winds and other tension during the storm caused the wastewater main to become compromised. Our engineers became alarmed at the spalling occurring as well as the condition of the lines themselves. A rupture in these lines would certainly yield a natural disaster as well as a public health crisis, putting residents and the environment in peril for an extended period of time. Precious resources, including sanctuaries, agricultural resources, and endangered coral reefs would also be critically adversely affected.

The City of Key West's experience in implementing large-scale infrastructure projects in accordance with the requirements of State and Federal granting agencies is both recent and significant. The management team convened to oversee this project has the full confidence and support of City Administration and the City Commission to implement this project with efficiency and fiscal responsibility.

We thank you in advance for your consideration of this proposal, and look forward to your support as we seek to make Key West a pafer and more resilient community.

### RESOLUTION NO. 18-205

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE MANAGER APPLY TO FOR FEMA MITIGATION GRANT PROGRAM (HMGP) FUNDING AND/OR COMMUNITY DEVELOPMENT BLOCK GRANTS FUNDING CITY FOR SEVERAL INFRASTRUCTURE PROJECTS IDENTIFIED HEREIN, IN THE AMOUNT OF \$28,688,956.00 (75%) WITH A LOCAL MATCH NOT TO EXCEED \$9,562,985.00 (25%); PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Florida Division of Emergency Management (DEM) has announced the availability of FEMA Hazard Mitigation Grant Program (HMGP) funds resulting from the Presidential Disaster Declaration for Hurricane Irma (FEMA 4337-DR-FL). This funding helps communities implement measures to reduce or eliminate risks from natural hazards; and

WHEREAS, the U.S. Department of Housing and Urban Development (HUD) - working in concert with Florida Department of Economic Opportunity - have developed an Action Plan for Disaster Recovery for Hurricane Irma has announced \$616 million in Community Development Block Grants (CDBG) will be made available to Florida in support of long-term hurricane recovery efforts, and

WHEREAS, FEMA, the Florida Division of Emergency Management and HUD require local legislative approval for City staff to apply for such funding; and

WHEREAS, this approval doesn't obligate the City to commit to accepting such grants, nor providing the local match unless specifically authorized by subsequent Resolution(s) by this Commission, if eventually offered by FEMA/DEM/HUD, and

WHEREAS, the City Commission acknowledges the local twenty-five percent (25%) match that accompanies such grant funding, if offered by FEMA/DEM/CDBG and eventually accepted by the City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager, upon the advice and consent of the City Attorney, is authorized to apply for FEMA Hazard Mitigation Grant Program (HMGP) and/or Community Development Block grant (CDBG) funding opportunities in the amount of \$28,688,956.00 (75%), with a local twenty-five percent (25%) match not to exceed \$9,562,985.00, as identified in Attachment A.

Section 2: Return to the City Commission with any resulting FEMA/DEM/CDBG grant offers for acceptance, approval and local match funding.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.

The City will complete a joint application to USACE, FL Dept of Environmental Protection (DEP), and the South Florida Water Management District for Environmental Resource Permit (ERP). The City will request a separate DEP permit for Notification/Application for Constructing a Domestic Wastewater Collection/Transmission System. Upon completion, a follow-up permit is required for service called the Request for Approval to Place a Domestic Wastewater Collection/Transmission System into Operation. USACE will contact Fish and Wildlife during the permitting process, and may require a biological opinion. A DEP permit and FL Keys Aqueduct Permit to install a new water supply line, specifically, a Notice of Intent to Use General Permit for Construction of Water Main Extensions, is also required.

Dear Ms. Trawick,

As a member of Monroe County's Local Mitigation Strategy, the City of Key West wishes to transfer federal funds between two projects it has been awarded HMGP funds for.

#223, Force Main Relocation Project: The Force Main is #8 on Monroe County's prioritized LMS list, and the City of Key Wests highest ranking project. The Fleming Bridge was hit twice during Irma, greatly threatening the entire sewer system. Due to unforeseen changes with this very complex project, the total cost ballooned leaving the City with a 75% cost share. The City has been very active in trying to find funds to complete this project, including applying for additional funds (21%) from FDEO DR (8/19) and requesting a cost overrun from FDEM (4/20). The City's local share still remains at 59% (\$5,219,350).

#415-R, Fire Station 361 Upgrades: The original Step 2 Application for the City's Fire Station 361 Upgrades was \$10,000,000 because they sought an entire building to protect 80% of their first responders. When advised that the Safe Room allotment would only fund a room, they downgraded their design and cost to \$2,959,998. Upon learning in March of 2020 that LMS partners Monroe County and the Village of Islamorada were able to achieve expanded "Safe Building" funding, the City renewed their desire for larger scale protection and approached FDEM about withdrawing the project and moving the allocated federal funds (\$2,219,991) to #223, the Force Main Relocation.

In summary: At its meeting of June 16th, 2020, the LMS saw no issue or objection with moving funds between projects of the same entity, especially when it solves problems for both projects.

The City of Key West would like to transfer \$2,219,991 (the entirety of its #415-R federal share) to the Force Main Project (#223), which would shift the cost share imbalance to a more reasonable 31% local share.

FDEO DR \$ 1,781,450 (21%)
City of Key West: \$ 2,639,959 (31%)






