A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "STATE OF FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY - FEDERALLY FUNDED COMMUNITY DEVELOPMENT BLOCK GRANT MITIGATION PROGRAM SUBRECIPIENT AGREEMENT" (CDBG-MIT) NUMBER MT011 FOR THE DUVAL STREET ECONOMIC CORRIDOR RESILIENCY AND REVITALIZATION PLAN, IN A TOTAL AMOUNT UP TO \$500,000.00 (\$565,310.00 CITY MATCH); AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT, AND TO APPROVE AND EXECUTE ANY SUBSEQUENT AMENDMENTS THAT MAY ADJUST THE GRANT FUNDING ALLOCATIONS TO THE CITY OR MODIFY THE PROJECT SCOPE, UPON CONSENT OF THE CITY ATTORNEY; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS OR TRANSFERS TO ACCEPT THE FUNDING; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 18-205, the City Commission authorized applications for FEMA Hazard Mitigation Grant Program (HMGP) and Community Development Block Grant (CDBG) funds for certain essential City infrastructure projects, including the Duval Street Economic Corridor Resiliency and Revitalization Plan; and

WHEREAS, the Florida Department of Economic Opportunity (DEO) is administering CDBG-MIT funds, which are federally awarded by the United States Department of Housing and Urban Development (HUD), to support long-term mitigation efforts following declared disasters in 2016 and 2017 through HUD's Community Development Block Grant (CDBG) Disaster Recovery Program; and

WHEREAS, the City of Key West was awarded funds for the purpose of preserving and protecting Duval Street as a major tourism destination and economic driver by mitigating risks and threats associated with natural and man-made disasters; and

WHEREAS, local legislative approval is necessary to allow City staff to accept such funding; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "State of Florida Department of Economic Opportunity Federally Funded Community Development Block Grant Mitigation Program (CDBG-MIT) Subrecipient Agreement" Number MT011 for the Duval Street Economic Corridor Resiliency and Revitalization Plan is hereby approved in an amount of up to \$500,000.00 (city match of up to \$565,310.00).

Section 2: That the Mayor is authorized to execute the Agreement and related documents, and any subsequent amendments that may adjust funding or the project scope, upon the advice and consent of the City Attorney.

Section 3: That necessary budget transfers or adjustments to accept the grant funding are hereby authorized. This project is budgeted in grant revenue account 101-0000-331-5001 (Infrastructure Surtax/Revenue/FEMA Grant/Reimbursement), and

expense account 101-1900-519-6300 (Infrastructure Surtax/Non-Departmental/Infrastructure), Project IS19002102. Matching city funds of \$565,310.00 are budgeted, for a total project cost of \$1,065,310.00.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
