A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "STATE FLORIDA DEPARTMENT OF ECONOMIC OPPORTUNITY FEDERALLY **FUNDED** DEVELOPMENT BLOCK GRANT DISASTER RECOVERY SUBRECIPIENT AGREEMENT" (CDBG-DR) NUMBER IR008 FOR THE FORCE MAIN RELOCATION PROJECT, IN Α TOTAL AMOUNT \$1,781,450.00; AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT, AND TO APPROVE AND EXECUTE ANY SUBSEQUENT AMENDMENTS THAT MAY ADJUST THE GRANT FUNDING ALLOCATIONS TO THE CITY OR MODIFY THE PROJECT SCOPE, UPON CONSENT OF THE CITY ATTORNEY; AUTHORIZING NECESSARY BUDGET ADJUSTMENTS OR TRANSFERS TO ACCEPT THE FUNDING; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 18-205, the City Commission authorized applications for FEMA Hazard Mitigation Grant Program (HMGP) and Community Development Block Grant (CDBG) funds for certain essential City infrastructure projects, including the force main relocation project; and

WHEREAS, the Florida Department of Economic Opportunity (DEO) is administering CDBG-DR funds, which are federally awarded by the United States Department of Housing and Urban Development (HUD), to support disaster recovery needs related to damages from Hurricane Irma through HUD's Community Development Block Grant (CDBG) Disaster Recovery Program; and

WHEREAS, the City of Key West was awarded funds for project implementation and engineering services related to the Force Main Relocation Project, which will resolve a vulnerability in the City's wastewater conveyance system by replacement/relocation of wastewater conveyance damaged by Hurricane Irma; and

WHEREAS, Agreement No. IR008 CDBG-DR funds will partially cover up to \$1,781,450.00 for project implementation and engineering services to be used as non-Federal match to FEMA Hazard Mitigation Grant Program (HMGP) funding. HMGP funding partially covers design costs and, pending FEMA approval, construction costs; and

WHEREAS, local legislative approval is necessary to allow City staff to accept such funding; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "State of Florida Department of Economic Opportunity Federally Funded Community Development Block Grant Mitigation Program (CDBG-DR) Subrecipient Agreement" Number IR008 for project implementation and engineering services related to the Force Main Relocation Project is hereby approved in an amount of up to \$1,781,450.00.

Section 2: That the Mayor is authorized to execute the Agreement and related documents, and any subsequent amendments that may adjust funding or the project scope, upon the advice and consent of the City Attorney.

Section 3: That necessary budget transfers or adjustments to accept the grant funding are hereby authorized. This project is budgeted to a maximum reimbursement amount of grant revenue in account 401-0000-331-3602 (Sewer Fund/Revenue/FEMA Grant), and expense account 401-3503-535-6500 (Sewer Fund/Renewal and Replacement/Construction in Progress), Project SE35031802.

Section 4: That this Resolution shall go into effect

the signature of the Presiding Officer and the Clerk of the
Commission.
