ACTION STATEMENT

Resolution rejecting bids for ITB #22-008 Margaret Street Fire Pump Building – Key West Historic Seaport

BACKGROUND

EXECUTIVE SUMMARY

The Margaret Street fire pump supplies A, C, D, E and F docks within the Key West Bight Marina. Although the system is currently functioning properly it is reaching the end of its useful life and should be replaced in the near future. Staff has budgeted for the replacement of all fire pumps within the City's marinas in FY23.

The Key West Bight Management District Board rejected these bids through res 22-09.

PURPOSE & JUSTIFICATION

ITB #22-008 was advertised June 2022 with two bids received on August 3, 2022 as follows:

American Empire Builders, Inc \$ 965,000.00

Charley Toppino & Sons, Inc \$1,242,714.23

Staff reviewed the breakdown of the proposals received and determined the line item pricing to be unbalanced and overall costs significantly exceeding the project budget. Also, the low bidder American Empire Builders did not provide the required self-perform or subcontractors list. And neither proposer provided a schedule of values for all lump sum items as required in the Bid Documents. It is in the best interest of the City to reject bids for these reasons. Staff will reevaluate and adjust project scope to move project forward in the near future.
