A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTIONS 2-797(4) (b) OF THE CODE OF ORDINANCES THE PURCHASE OF CISCO 9410R MULTILAYER SWITCH AND RELATED PRODUCTS AND SERVICE FROM CDW-GOVERNMENT (CDW-G), PURSUANT TO GOVERNMENT CONTRACT (NASPO VALUE POINT 43220000-NASPO-119-ACS, STATE OF FLORIDA DEPARTMENT OF MANAGEMENT SERVICES), PURSUANT TO SECTION 2-797(3) AND 2-797(4) OF THE CODE OF ORDINANCES IN AN AMOUNT NOT TO EXCEED \$78,688.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City staff recommends the purchase of certain CISCO Brand equipment and installation/support services from CDW-G, Inc., pursuant to government contract, pursuant to section 2-797(3) of the Code of Ordinances; and

WHEREAS, the City Manager has additionally determined that the procurement of Cisco Equipment, as described in the attached price quote, is in the best interests of the City pursuant to section 2-797(4) (b) of the Code of Ordinances; and

WHEREAS, as part of the American Rescue Plan Act (ARPA), the City received funding through the Florida Division of Emergency Management (Resolution 21-191, Agreement No. Y5151)

for financial assistance supporting critical infrastructure, including the new multilayer CISCO switch; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a new Cisco 9410R Multilayer Switch with related products and service from CDW-G, in an amount not to exceed \$78,688.00 is hereby approved, pursuant to section 2-797(3) and 2-797(4) of the Code of Ordinances.

Section 2: It is anticipated that the cost of this purchase will be covered by ARPA grant funding. The purchase will be paid from budget account number 001-1303-513-6400, and any necessary budget transfers and amendments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
