A motion was made by Commissioner Cunningham, seconded by Commissioner Bravo, in accordance with Sec. 110-291, that the City of Key West enter into a compliance settlement agreement with the respondent for the structural root damage to (1) Mahogany tree at the corner of Southard and Whitehead Street. The respondent is required to:

- 1) Remove the existing tree to be replaced with a 45-65 gallon, sub-canopy or canopy tree from the approved list, FL #1, and as approved by the Florida Department of Transportation
- 2) Provide one year of maintenance for the replacement tree to ensure survival, including follow-up maintenance to neighboring affected trees by covering up exposed roots with soil and gravel to aid recovery
- 3) Make the resulting wood from the removed Mahogany tree available to local artists.
